The Bank of East Asia (U.S.A.) N.A. reserves the right to change these terms and conditions at any time without notice.

Fees and commissions quoted herein apply to standard transactions. Special services are subject to a charge commensurate with the time and work involved. All postage, swift, telephone and incidental expenses as well as correspondents' charges, if any, are for your account.

Pursuant to the USA Patriot Act of 2001 (US Public Law 107-56), U.S. banks are required to obtain from each bank organized outside the U.S. with whom they maintain a correspondent relationship (as defined) certification of selected information. Such information includes, but is not limited to, the Bank's ownership, physical location, its regulated - affiliate status, its intended usage of correspondent accounts and its process agent in the U.S. We must obtain an initial certification and recertification thereafter once every three years from each non-U.S. bank for whom we establish a correspondent relationship.

As part of our anti-money laundering (AML) policies and procedures and as required by applicable laws, we conduct Know Your Customer (KYC) due diligence on all our banking clients which includes general as well as enhanced due diligence as needed and electronic AML monitoring of transactions on an ongoing basis. Our AML policies and procedures may include requesting information about a client's (i) documented AML/KYC policies and procedures; (ii) general and enhanced due diligence procedures to aid in the detection of potential money laundering; (iii) KYC practices relating to the establishment of new relationships and the monitoring of current relationships to comply with all applicable AML laws; and inquiries about specific transactions going through your accounts with us.

We thank you for your cooperation in these matters.

These Terms and Conditions shall be governed by and construed in accordance with, and your account relationship with us will be governed by, the laws of the State of New York, USA, exclusive of its rules governing conflicts of laws. All claims and disputes relating to these Terms and Conditions, and your account relationship, shall be heard exclusively by courts within the State of New York, USA. Each party waives the right to trial by jury in any action arising out of our relationship.

To have payment made in Federal Funds through the Federal Reserve System, you must so specifically instruct us. For payments in other currencies, the value date will be the date in accordance with prevailing market practice.

Funds we receive for your account through Interbank Payments Systems are subject to final collection in accordance with the rules of the respective System. If claim is made on us for recovery of any part of any item after final payment thereof on the grounds that such item was altered or bore a forged or unauthorized endorsement or was otherwise not properly payable, we reserve the right to withhold from your account the amount of such claim until final determination thereof, and to charge your account or otherwise recover from you whatever amount we may determine to be our liability on account of such claim.

Unless otherwise agreed, we will make payments in settlement of transactions received after 1:00 PM on the next business day.
