

Terms and Conditions of the Overseas Spending Double Reward Programme

1. The Overseas Spending Double Reward Programme (the “Programme”) is only applicable to holders of BEA World MasterCard (the “Cardholder”), while holders of BEA PLATINUM Card, BEA Gold Card, BEA Classic Card, BEA Renminbi Credit Card, BEA Prepaid Card and BEA Corporate Card are excluded.
2. The Cardholder may enjoy double Bonus Points (the “Double Reward”) for overseas retail transactions settled with the BEA World MasterCard. Each eligible BEA World MasterCard account is entitled to receive a maximum of 120,000 extra Bonus Points per year (from March of the current year to February of the next year).
3. The Double Reward is applicable to all retail transactions that are made overseas and posted in any currency other than Hong Kong dollars. The Double Reward is not applicable to cash advances, casino chips, mail or phone orders, and/or online purchases and payment.
4. The Double Reward will be counted monthly (from the first to the last day of each month, based on transaction date) and automatically credited to the relevant BEA World MasterCard account in the next month. Details will appear on the Cardholder’s monthly statement.
5. The Cardholder must retain all original sales slips. In case of any dispute, The Bank of East Asia, Limited (“BEA”) reserves the right to request the Cardholder to submit the relevant original sales slip and/or such further document(s) and/or evidence for inspection. All sales slips submitted to BEA will not be returned.
6. Unposted/cancelled/refunded transactions and transactions that are found fraudulent or eventually cancelled/refunded will not be considered as eligible transactions for any Double Reward. BEA shall be entitled to debit or charge back any such Double Reward that has already been given to the Cardholder at a conversion rate of HK\$1 per 200 Bonus Points without prior notice.
7. The Double Reward cannot be converted into cash or transferred. Only the Cardholder whose BEA World MasterCard account is valid and in good standing at the time the Double Reward is given will be eligible to receive the Double Reward.
8. BEA reserves the right to vary or cancel the Programme and/or amend or alter any of these Terms and Conditions at any time without prior notice. In the event of any dispute, the decision of BEA shall be final and conclusive.
9. Unless otherwise stated herein, words and expressions as defined in the BEA World MasterCard Cardholder Agreement (Personal Account) and/or BEA Credit Cardholder Agreement (Personal Account) (collectively called “the Cardholder Agreement”) shall have the same meaning when used in these Terms and Conditions. For the avoidance of doubt, nothing in these Terms and Conditions shall prejudice or affect the terms and conditions of the Cardholder Agreement. These Terms and Conditions shall apply in addition to and in conjunction with the terms and conditions of the Cardholder Agreement.
10. Should there be any discrepancy between the English and the Chinese versions of these Terms and Conditions, the English version shall apply and prevail.
