2. 按揭保險計劃及非按揭保險計劃的貸款批核書中有關存款掛鈎按揭貸款的條款及細則修訂 由 2020 年 7 月 2 日起,任何已持有本行存款掛鈎按揭貸款的客戶,其存款掛鈎按揭優惠 存款利率的存款上限已更新為未償還貸款本金金額的 50%,或港幣二百萬元,以較低者為 準。有關詳情,客戶亦可參閱本行於 2020 年 6 月發出之修訂通知。

Notice of Amendments to BEA Mortgage Loan Services

1. Amendments to the fee and charges for mortgage loan services

With effect from 1st June, 2021 (the "Effective Date"), the fees and charges in connection with the mortgage loan services provided by The Bank of East Asia, Limited (the "Bank") will be amended as follows:

1. Copy of facility letter or title deed (e.g. mortgage deed/deed of	HK\$200 per set	HK\$300 per set
assignment/sale and purchase agreement/ deed of mutual covenant)		
2. Changes of loan terms (e.g. installment amount, loan tenor, repayment option/frequency, switch of mortgage plans)	HK\$1,000	HK\$1,500
3. Custody of non-discharged deeds after full loan repayment	HK\$3,000 per	HK\$ 4,000 per annum

2. Amendments to the terms and conditions of facility letters in relation to BEA deposit linked mortgage loans under the Mortgage Insurance Program ("MIP") and Non-Mortgage Insurance Program ("Non-MIP")

With effect from 2nd July, 2020, for customers who have held a deposit-linked mortgage loan with the Bank, the saving deposit limit for preferential deposit rate under deposit-linked mortgage was changed to 50% of the outstanding principal of the loan, or the amount of Two Million Hong Kong Dollars, whichever is lower. Please refer to relevant notice of amendments previously issued by the Bank in June 2020 for details.

Please note that each of the changes above is binding on you if you continue to use our mortgage loan services after the Effective Date. Please also note that we shall not be able to continue providing you mortgage loan services to you if you do not accept the above changes.
