

Terms and Conditions for "Preferential Conversion Rate of 8 Bonus Points = 1 Mile & Handling Fee Waiver for Miles Conversion for designated BEA World Mastercards & Platinum Cards"

- 1. This promotion runs from 3 October 2024 to 31 December 2024, both dates inclusive (the "Promotional Period").
- 2. The promotion only applies to principal cardholders (the "Designated Cardholders") of designated BEA World Mastercards and Platinum Cards ("Eligible Credit Card") listed below.

 (Designated BEA World Mastercards: BEA Flyer World Mastercard, BEA SupremeGold World Mastercard & BEA World Mastercard, who have successfully registered for the BEA Mileage Reward.

 Designated BEA Platinum Cards: BEA Mastercard Platinum Card & BEA VISA Platinum Card.)
- 3. The promotion is only applicable to the first 5,000 Designated Cardholders (the "Eligible Cardholders") who successfully register for the promotion with their Eligible Credit Cards and their valid Cathay membership in the BEA Mall App during the period from 3 October 2024 to 30 November 2024 ("Registration Period"). The Cardholder must register the number of a valid Cathay membership the bears the same name as the Cardholder. The Cardholder only needs to register for the promotion once. After successful registration, BEA will send an email to the Cardholder's email address as provided during registration. The offer is subject to a quota and is available on a first-come first-served basis. Registration status and quota are determined by the computer records of BEA.
- 4. Cardholders who fail to successfully register and provide the number of their valid Cathay membership during the Registration Period will be deemed to have forfeited the reward and will be ineligible to get any reward. BEA and Asia Miles Limited (the "Merchant") will not be liable for Asia Miles being lost or crediting being delayed as a result of either the Cardholder providing incorrect information (including but not limited to a discrepancy between the Cathay membership number and/or membership name and the registered Cardholder name on the Eligible Credit Card) or providing incomplete information.
- 5. Each Eligible Cardholder only needs to successfully register once during the Promotional Period, and fulfil the specified requirement with a valid Eligible Credit Card in order to earn the reward. Even if the Eligible Cardholder holds more than one Eligible Credit Cards, the Eligible Cardholder is only required to register once with any of their Eligible Credit Cards for the Promotion, and the posted and accumulated Bonus Points within the valid period of any eligible principal cards under their name ("Eligible Bonus Points") will be combined to calculate the reward during the Promotional Period.
- 6. An Eligible Cardholder who holds 30,000 or more eligible Bonus Points after deducting the one-time 10,000 Bonus Points required to register for the promotion between 3 October 2024 to 31 December 2024* ("Bonus Points Deduction Period") can enjoy the promotion "Preferential Conversion Rate of 8 Bonus Points = 1 Mile & Handling Fee Waiver for Miles Conversion". If the Eligible Cardholder does not have enough Bonus Points for the "One-time 10,000 Bonus Points required to register for the promotion" and "Bonus Points required for converting Miles at the preferential conversion rate", the cardholder will be deemed to have forfeited the reward and will be ineligible to get any reward and the one-time 10,000 Bonus Points required to register for the promotion will not be deducted.
- 7. "Preferential conversion rate of 8 Bonus Points = 1 Mile" Offer: During the Bonus Points Deduction Period, if the Eligible Cardholder hold enough eligible Bonus Points* to fulfil the Rewards Tier (up to 400,000 Bonus Points in total through this promotion, which is equivalent to a maximum of 50,000 Miles) after deducting the one-time 10,000 Bonus Points required to register for the promotion, Bonus Points will be deducted from the Eligible Credit Card for Miles Conversion on the designated Bonus Points Deduction Dates (three rounds in total: the first round is on or before 31 October 2024; the second round is on or before 30 November 2024; the final round is on or before 31 December 2024*). The bank will convert the deducted Bonus Points into Asia Miles and credit these to the Cardholder's registered Cathay membership account directly on or before February 2025, without further notice.

(+ the final round of Bonus Points Deduction will be calculated based on the eligible Bonus Points held by the cardholder on 10 December 2024, and will be deducted on or before 31 December 2024.

- Each Eligible Cardholder can redeem up to 400,000 Bonus Points in total through this promotion, which is equivalent to a maximum of 50,000 Miles. <u>The Cardholder agrees to and authorise the</u> conversion by BEA of the relevant Bonus Points into Asia Miles as its fulfilment of the Offer under <u>this promotion.</u>
- 10. A Cardholder who has failed to receive their Miles within the period mentioned in Clause 6 is required to inform BEA by 31 March 2025, otherwise they will be deemed to have forfeited the reward.
