Background 背景資料

BEA (MPF) Value Scheme (the “Master Trust”) is a Registered Provident Fund Scheme established by a trust deed dated as of 17th August, 2012 (as amended, the “Trust Deed”). The SVC Applicant has elected to participate as a Special Voluntary Contribution Account Member of the Master Trust and has agreed to contribute to the Master Trust on the terms of this Agreement.

東亞(強積金)享惠計劃(「本集成信託」)是一項於2012年8月17日訂立的信託契據(經修訂「信託契據」)所成立的註冊公積金計劃。特別自願性供款賬戶申請人已選擇以特別自願性供款賬戶成員身份參與本集成信託，並同意依據本集成信託之條文向本集成信託作出供款。

Agreement of the parties 訂約方的協議

1. The Trustee and Sponsor agree that the SVC Applicant shall become a Member of the Master Trust with effect from the date specified in the Schedule to this Agreement.
受託人和保薦人同意，特別自願性供款賬戶申請人須由本協議附表所指定日期起成為本集成信託所指的成員。
- 2.1 The SVC Applicant agrees to be bound by and covenants to comply with the provisions of the Trust Deed as from time to time in force and to perform any act or pay any sum required for the purposes of the Master Trust insofar as attributable to the SVC Applicant.
特別自願性供款賬戶申請人同意契諾遵守及受制於不時生效的信託契據條文，以及履行或支付其向本集成信託所需作出的任何行為或所需支付的任何款項(以特別自願性供款賬戶申請人所佔部分為限)。
- 2.2 The SVC Applicant gives the covenants as provided in Clause 10.2 of the Trust Deed and the covenants, warranties, undertakings and indemnities required by the provision of the Trust Deed. In addition, the SVC Applicant represents that he or she falls under any one of the following categories: (i) an employee, (ii) a self-employed person¹, or (iii) a member or a former member of an MPF scheme², an ORSO exempted scheme³ or a registered ORSO scheme.

- 3.1 The Trustee and the SVC Applicant agree that the SVC Applicant shall at any time be entitled on request to the Trustee in the form specified by the Trustee to payment of all or part only of the amounts as agreed by the Trustee from time to time attributable to the SVC Applicant's voluntary contributions.

- 3.2 Unless the Trustee otherwise agrees, all payments of contributions by the SVC Applicant to the Master Trust shall be paid to the Trustee in Hong Kong dollars by direct debit authorisation or cheque from an account with a bank in Hong Kong as described in the Schedule. Contributions in cash is not allowed unless otherwise agreed by the Trustee.

4. The SVC Applicant agrees to pay all fees, expenses and other liabilities which are payable by the SVC Applicant in accordance with the Trust Deed or this Agreement.

5. The Trustee gives the covenants as provided in Clause 13 of the Trust Deed to the SVC Applicant.

6. Unless and until instructed otherwise, the signature of the SVC Applicant on this Agreement shall be treated as a specimen signature for the purpose of future verification of written instructions to the Trustee and/or the Sponsor by the SVC Applicant.

7. Unless the Trustee otherwise agrees, any request by the SVC Applicant to withdraw only part of the amount attributable to the SVC Applicant's voluntary contributions shall be for a minimum of HK\$5,000.

8. The SVC Applicant confirms that it has received, read and understood the MPF Scheme Brochure of the Master Trust before entering into this Agreement.

9. The SVC Applicant confirms that the information, covenants, warranties, undertakings and representations provided by the SVC Applicant in this Agreement (including the Schedule) are true and accurate as of the date hereof and shall promptly notify the Trustee of any change thereof. The SVC Applicant acknowledges that the Trustee relies on the information, covenants, warranties, undertakings and representations of the SVC Applicant in entering into this Agreement and agrees to indemnify and hold harmless the Trustee for any losses, liabilities, costs or expenses that the Trustee may suffer or incur by reason of, or in connection with, any breach by the SVC Applicant of any covenant, warranty, undertaking or representation made herein or any misrepresentation made by the SVC Applicant or any inaccuracy of the information provided by the SVC Applicant.

10. Unless the context otherwise requires, words and expressions defined in the Trust Deed have the same meanings in this Agreement.

12. No person other than the SVC Applicant or the Trustee or the Sponsor will have any right under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong) to enforce or enjoy the benefit of any of the provisions of the terms of the Agreement.

A. 100% Invest in Default Investment Strategy ("DIS") 預設投資策略
 DIS is a ready-made investment arrangement mainly designed for those members who are not interested or do not wish to make a fund choice, and is also available as an investment choice itself, for members who find it suitable for their own circumstances.
 The DIS of the Master Trust is not a fund – it is a strategy that uses two constituent funds, i.e. the BEA Core Accumulation Fund (the "Core Accumulation Fund") and BEA Age 65 Plus Fund (the "Age 65 Plus Fund") to automatically reduce the risk exposure as the member approaches retirement age. Core Accumulation Fund will invest around 60% in higher risk assets (higher risk assets generally means equities or similar investments) whereas the Age 65 Plus Fund will invest around 20% in higher risk assets. Switching of the existing accrued benefits among Core Accumulation Fund and Age 65 Plus Fund will be automatically carried out each year on a member's birthday[⊕] and according to the allocation percentages as shown in the DIS de-risking table. For further details, including the product features, de-risking mechanism and table, fees and charges, investment rules and procedures, and the risk factors involved, please refer to the MPF Scheme Brochure of the Master Trust.
