嘉許計劃目的：

- 推動及促進僱主遵守強積金法例
- 鼓勵僱主為僱員提供更佳的退休福利
- 嘉許致力保障及加強僱員退休福利的模範僱主

- To promote and foster compliance with MPF legislation by employers
- To encourage employers to provide better retirement benefits for their employees
- To recognize employers who are exemplary in enhancing the retirement benefits of their employees

資格及獎項



Eligibility and Awards

積金好僱主

「積金好僱主」是一個年度嘉許計劃，涵蓋2017年4月1日至2018年3月31日。僱主符合以下條件便可申請：

1. 參加強積金計劃達一年或以上（截至2018年3月31日）；
2. 遵守強積金法例；及
3. 為僱員提供額外退休保障，符合以下最少一項條件：

- 提供多於一個強積金計劃供僱員選擇；或
- 為僱員作出強積金自願性供款；或
- 為僱員提供其他與強積金制度有關的退休福利。

Good MPF Employer Award

The Award is granted on an annual basis, covering the period from 1 April 2017 to 31 March 2018. Employers who fulfil the following criteria may submit an application for the Award:

1. At least one year's participation in an MPF Scheme (as of 31 March 2018);
 2. Compliance with the MPF legislation; and
 3. Provision of better retirement protection for employees. Employers must have fulfilled at least one of the following criteria:
- Offered more than one MPF scheme for employees to choose from; or
 - Offered MPF voluntary contributions for their employees; or
 - Offered their employees other forms of retirement benefits that are related to the MPF System.



特別獎項

僱主如符合條件參加「積金好僱主」嘉許計劃，可同時申請以下兩個特別獎項：

「積金供款電子化獎」

僱主須在該計劃年度內的任何三個月或以上，透過電子方式，遞交付款結算書或繳付強積金供款予受託人。

「推動積金管理獎」

僱主須在該計劃年度內，向僱員提供最少兩項與管理強積金相關的協助。

SPECIAL AWARDS

Employers who fulfil the criteria of the Good MPF Employer Award can apply for these two special awards at the same time.

e-Contribution Award

Employers must have submitted remittance statements or contributions to their trustees electronically for a total of 3 months or more during the award year.

Support for MPF Management Award

Employers must have provided their employees with at least two kinds of support services that could help them manage their MPF during the award year.
