

"BEA Credit Card x AIRSIM Travel offer" Terms and conditions

- The promotional period is valid from 15th April to 31st May, 2024, both dates inclusive (the "Promotional Period") and is divided into 2 phases as follows, spending is calculated based on relevant transaction dates as recorded by AIRSIM:
 - i. "Phase 1": 15th April to 30th April, 2024
 - ii. "Phase 2": 1st May to 31st May, 2024
- 2. The promotion applies to cardholders of an eligible BEA credit card ("Cardholders"), except for the BEA UnionPay Dual Currency Credit Card, BEA JCB PLATINUM Card and Corporate Card ("Eliglible Card").
- 3. Cardholders are entitled to a 30% rebate of the purchased value of designated AIRSIM Data Package(s) on selected locations in each phase by using a eligible BEA credit card to pay at the AIRSIM Hong Kong website (www.airsim.com.hk/bea) or AIRSIM app with promo code "BEATRAVEL" during the Promotional Period. Phase 2	Thailand	On or before 10 th June, 2024

- 4. The AIRSIM Data Package(s) shall be valid for trips started within 4 months from the date of purchase. The packages shall not be valid for trips started later.
- 5. The rebate can only be used to purchase AIRSIM data packages or AIRTALK (no other products). The rebate remains valid for one year from the date of purchase of the above-mentioned data package(s) for designated destinations.
- 6. Cardholders who do not have an AIRSIM card can obtain one together with the selected data package(s) when buying their data package(s) from the AIRSIM Hong Kong website (www.airsim.com.hk/bea). They can choose to receive the AIRSIM card by regular post or by courier, or they can collect it in person from an AIRSIM pick-up point in Causeway Bay or Sha Tin. The courier option will involve additional delivery costs; please contact AIRSIM for details.

- 8. Only applicable to AIRSIM physical card, not applicable to AIRSIM Corporate Customer Accounts.
