

## "BEA Credit Card x Booking.com Offer" Terms and Conditions

- 1. This promotion runs from 1<sup>st</sup> September to 31<sup>st</sup> December, 2023, both dates inclusive (the "Promotional Period").
- Offer runs until 23:59 on 31<sup>st</sup> December, 2023. Applies to periods of stay from now until 30<sup>th</sup> June, 2024.
- 3. The promotion only applies to the principal and supplementary cardholders (the "Cardholders"), who hold BEA Credit Cards or Co-branded Cards, excluding BEA JCB PLATINUM Card, UnionPay Dual Currency Credit Card and Corporate Card ("Eligible Credit Cards"), issued by The Bank of East Asia, Limited ("BEA"). Cardholders must use a valid Eligible Credit Card to pay in full at Booking.com designated website (www.booking.com/beahk) during the Promotional Period in order to enjoy the Offer.
- Offer: Up to a 7% rebate at Booking.com
  Offer only applies to hotel bookings made through Booking.com's designated webpage at www.booking.com/beahk (the "Promotion Webpage").
- 5. Offer only applies to selected pre-paid rooms with "Cashback" tag, and for which you select "Pay now" and pay in full at the time of reservation. Offer does not apply to rooms selected as "Pay at Hotel".
- 6. Hotel bookings made directly through the main Booking.com website (www.booking.com) or Booking.com app (without being accessed via the BEA Webpage) will not be eligible for the offer, and refunds will not be arranged.
- 7. The Offer is applicable to hotel room charges only and is not applicable to local government taxes, service charge, cancellation fees or other charges.
- 8. The Offer is subject to availability and the terms and conditions stipulated by the respective participating hotels.
- 9. The Cashback is calculated based on the hotel room charges in Euros and will be credited in Euros to the Eligible Credit Card account. The relevant rebate will be automatically credited to Wallet Credits (Credits) created by Booking.com B.V. within 64 calendar days of the end of your hotel stay.
- 10. The Cashback is calculated with reference to the transaction date of the Booking and all Bookings must be conducted during the Promotional Period. All Booking effected by the same Cardholder (with the same identity document) under various Eligible Credit Cards will be separately counted. Primary Cardholder and additional Cardholder under the same Eligible Credit Card account shall for all purposes of this promotion be treated as separate Cardholders and are each eligible to enjoy the Offer under this promotion using the Eligible Credit Cards under their respective names.
- 11. Offer applies to selected room types and destinations only.
- 12. Offer applies to hotel room charges only. Local government taxes and service charges may apply in addition.
- 13. Offer does not apply to bookings made through the Booking.com app using Apple Pay.
- 14. Offer is subject to hotel room availability. You are required to present your BEA credit card during hotel check-in.
- 15. A cancellation or change of schedule must be arranged directly through the designated Booking.com webpage or hotline, and will be subject to the terms and conditions of the hotel in question. Please refer to the Booking Confirmation email or call the Booking.com hotline for details.
- 16. Other terms and conditions apply. Please refer to the "Booking and Cancellation Terms and Conditions" on the designated Booking.com webpage.
- 17. BEA and Booking.com will determine the eligibility of Cardholders and the applicable Cashback amount based on their Cardholders' transaction records.
- 18. The Cashback cannot be converted into cash or be withdrawn as a cash advance and is not transferable. It can be used for subsequent credit card purchases only and cannot be used to settle any previous outstanding balance.
- 19. The total amount of Cashback for the entire Promotional Period will be rounded up to the nearest integer.
- 20. Cardholders must keep all original sales slips or official payment records in respect of the Eligible Transactions. In case of any dispute, BEA reserves the right at any time during or after the promotion to request a Cardholder to submit the relevant original sales slips, official payment records, and/or such further documents or evidence as may be required for inspection. All sales slips, official payment records and other documents or evidence submitted to BEA will be retained by BEA and will not be returned to the Cardholders.



- 21. Where the Cashback has been credited to a credit card account and there is a subsequent reversal of any transaction(s) in respect of which the Cashback was awarded, BEA has the right to deduct such Cashback directly from the credit card account without prior notice.
- 22. Fraud and abuse will result in forfeiture of a Cardholder's eligibility to participate in the promotion as well as cancellation of a Cardholder's credit card(s). BEA further reserves the right to deduct any Cashback awarded under the Offer directly from the relevant credit card account without prior notice.
- 23. Only Cardholders whose Eligible Credit Card accounts are valid and in good standing during the entire Promotional Period and the offer fulfilment period will be eligible for the Offer.
- 24. All information and photos shown are for reference only.
- 25. The terms and conditions of the Cardholder's credit card agreement with BEA will continue to apply.
- 26. No person other than the Cardholder, BEA, or Booking.com will have any right under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong) to enforce or enjoy the benefit of any of the provisions of these Terms and Conditions.
- 27. BEA makes no representation or guarantee as to the quality and availability of the products, services, or information provided by Booking.com. BEA shall not be liable for any matters arising from or in connection with the products, services, or information provided by Booking.com. Cardholders should direct any queries to Booking.com. Shall there be any further existence of claims or disputes between cardholders and Booking.com, BEA should be informed of such claims or disputes within a reasonable period so that BEA can make corresponding handling.
- 28. BEA and Booking.com reserve the sole right to vary or cancel the Offer and/or amend or alter these Terms and Conditions at any time without prior notice. In the event of any dispute, the decision of BEA and Booking.com shall be final and conclusive.
- 29. These Terms and Conditions shall be governed by and construed in accordance with the law of Hong Kong. You submit to the non-exclusive jurisdiction of the Hong Kong courts but these Terms and Conditions may be enforced in the courts of any competent jurisdiction.
- 30. If there is any inconsistency or ambiguity between the English and Chinese versions of these Terms and Conditions, the English version shall apply and prevail.
