

"BEA Credit Card x Broadway Circuit Offer" - Terms and Conditions

- 1. The promotion runs from 1st January to 31st December 2023, both dates inclusive (the "Promotional Period").
- 2. The Offer does not apply on 1st to 2nd January, 19th to 31st January and 14th to 31st December, 2023.
- 3. The Offer applies to cardholders of an eligible BEA credit card, except for the BEA JCB PLATINUM CARD and BEA Corporate Card ("Cardholders"). Cardholders must use a valid BEA credit card to pay in full at cinema box office of Broadway Circuit ("Broadway Circuit") during the Promotional Period in order to enjoy the Offer.
- 4. Cardholders must state their intention to use their BEA credit card before making payment to enjoy the Offer.
- 5. The Offer only applies at the cinema box office of Broadway Circuit, not including its online booking platform.
- 6. The Offer is applicable to the regular price of matinee and night shows (including 2D, RealD 3D, 4DX and IMAX movies).
- 7. Maximum 8 tickets for the Offer can be used in each transaction.
- 8. The Offer is not applicable to VIP houses, all tickets at morning show and all shows on Tuesday, Special Event, Film Festival and those films with special engagement with film distributors.
