

Terms and Conditions of "BEA Credit Card - Concert Ticket Lucky Draw"

From 12 March 2025 to 6 April 2025, customers of the Bank of East Asia, Limited ("BEA") who have successfully registered the Lucky Draw with bonus points and completed designated missions will automatically be eligible to the BEA Credit Card Lucky Draw (the "Lucky Draw").

1. The Lucky Draw is organized by BEA.

- 2. The Lucky Draw period is calculated based on the transaction date from 12 March 2025 to 6 April 2025, both dates inclusive (Hong Kong Time) (the "Promotional Period").
- 3. The offer is applicable to BEA Credit Card or Co-branded Cardholders ("Eligible Cardholders"), excluding BEA GOAL Credit Card, i-Titanium Card, JCB PLATINUM Card and corporate card ("Eligible Card").
- 4. Eligible Cardholders must use a valid physical Eligible Card, or conduct transaction made by mobile payments (Apple Pay, Google Pay™ and UnionPay App, excluding Alipay, AlipayHK, PayMe, WeChat and WeChat Pay HK) ("Eligible Mobile Payments") to complete designated missions during the Promotional Period to be entitled to chances to participate the Lucky Draw. The spending transactions of the supplementary card will be combined with the transactions of the principal card.
- 5. Registered Eligible Cardholders must register for the Lucky Draw with 3,000 bonus points via BEA Mall App with one of your Eligible Card(s), they can receive a Cupping Room HK\$10 e-voucher as "Registration Reward" ("Registration Reward"). The registration quota is 3,000 on a first-come-first-served basis and will be closed when the quota is full.
- 6. Registered Eligible Cardholders must complete at least one designated mission with any of their Eligible Cards to earn Lucky Draw chance(s) to be eligible for the prizes ("Eligible Customer"). Designated missions can be completed with any of the Eligible Customers Eligible Cards and include:

^{*}Eligible retail spending refers to retail transactions made by Eligible Cards during the Promotional Period, excluding: interest-free instalment for retail purchase, cash advances, online/Automatic Teller Machine (ATM) bill payments, tax payments, recurring transactions, auto-pay transactions, Octopus top-up transactions by any means (including but not limited to Automatic Add Value Service (AAVS), online or through mobile), digital wallets (including but not limited to Alipay, AlipayHK, PayMe, WeChat and WeChat Pay HK), fund transfers, purchase and/or recharging of prepaid cards, insurance premiums, designated local ticket agents (including but not limited to Cityline (Hong Kong) Limited, Hong Kong Ticketing (International) Limited and HotdogTIX Limited), transactions at any supermarkets, transactions to government departments, mail / fax / telephone orders, "Cash in Hand" programme-related amounts, finance charges, late charges, annual fees, bank charges, casino chip purchases, unposted/cancelled/refunded transactions, and transactions that are found to be fraudulent or are eventually cancelled/refunded.

- **Eligible Overseas retail spending refer to (a) retail transactions made outside of Hong Kong and posted in any currency other than Hong Kong dollars, (b) transactions settled in Hong Kong dollars under Dynamic Currency Conversion, and (c) online transactions posted in any currency other than Hong Kong dollars.
- 7. There is no cap for the number of Lucky Draw chances each Eligible Customer can accumulate with their Eligible Cards during the Promotional Period.

Provided that the Concert is postponed due to any reason, the Organiser will decide and announce the relevant arrangements for postponement, and Cardholders should follow the Organiser's public notice.
- 28. For any person who fails to comply with the Terms and Conditions, the Organiser and the venue management reserve the final decision on the admission of such person. If any of Cardholders is unable to enter the venue due to failure to comply with the Terms and Conditions released by the Organiser and the venue management, neither BEA, nor the Organiser and/or the venue management are required to make any compensation. In case of any dispute, BEA and the Organiser reserve the right of final decision.
- 29. The final admission and seating arrangements for the Concert is subject to the announcement made by the venue management and the latest guidelines of the Organiser.
