## "Up to 10% cash rebate + extra rewards at selected Green Merchants" Terms and Conditions

- 1. This promotion runs from 15 January 2025 to 30 June 2025, both dates inclusive (the "Promotional Period").
- 2. The promotion only applies to the cardholders (the "Cardholders"), who hold BEA Credit Cards or Co-branded Cards, excluding the BEA JCB PLATINUM Card and Corporate Card ("Eligible Credit Cards"), issued by The Bank of East Asia, Limited ("BEA"), during the Promotional Period. Cardholders must use a valid BEA credit card to pay in full at selected Green Merchants (the "Merchant") during the Promotional Period in order to enjoy the following offer.
- 3. a) Up to 10% cash rebate:

i. Only applicable to the first 3,000 cardholders who log in to the BEA Mall App and successfully register with an Eligible Credit Card during the Promotional Period. After Successful Registration, BEA will send an email to the Cardholder's email address as provided during registration. Registration status and quota are determined by the computer records of BEA. The offer is subject to a quota and is available on a first-come, first-served basis. If the Cardholder holds more than one eligible cards, the Cardholder only needs to register this promotion with one of the eligible principal cards, all eligible spending amounts of their eligible principal cards will be combined as one account to calculate Reward.

ii. Only applicable for spending at the physical outlets through Apple Pay / Google Pay or online spending at the selected Green Merchants: CATALO, FAIRTASTE, German Pool, GP, Green Price, GreenSTORE, Veda at Ovolo Central Hong Kong, Be With Years (Hung Hom Whampoa Shop) and WANAKA. Spending made via AlipayHK, PayMe, WeChat Pay HK and UnionPay App payment are ineligible.

iii. Each cardholder can enjoy a maximum of HK\$80 rebate per month during the Promotional Period. BEA will credit the relevant rebate to each Cardholder according to the corresponding accumulated Eligible Transactions, and the rebate is rounded down to the nearest whole number (less than HK\$1 of rebate amount will not be calculated).

- 8. If Cardholders cancel or refund part or all of the transaction related to a credit rebate after the rebate is credited or used, BEA reserves the right to charge the credit card account an amount equal to that credited or used without prior notice.
- 9. Any rebate credited can be used to offset the balance of the relevant card account only and will be rounded down to the nearest Hong Kong Dollar. Rebates earned are not transferrable. Rebates for a cancelled account will be automatically cancelled and cannot be refunded or transferred.
- 10. Un-posted/cancelled/refunded transactions and transactions that are found to be fraudulent or are eventually cancelled/refunded will be considered ineligible. If a transaction proves to be ineligible after the rebate is given, BEA shall be entitled to debit an amount equal to the value of the relevant rebate from the cardholder's account.
