

"BEA Credit Card x Expedia Travel Offer" Terms and Conditions

- 1. This promotion runs from 5th June, 2023 to 31st July, 2023, both dates inclusive (the "Promotional Period").
- 2. The Offer applies to cardholders of an eligible BEA credit card, except BEA Corporate Cards ("Cardholders").
- 3. The Offer applies to Cardholders of an eligible physical BEA credit card ("Eligible Credit Card"), transaction made by third party or e-wallet payment applications (including but not limited to Apple Pay, Google Pay, AlipayHK, WeChat Pay, PayPal, PayMe) are not allowed. To be eligible for the following offers ("Offer"), transactions must be settled in Hong Kong Dollar (HK\$) at the designated Expedia website (www.expedia.com.hk/beahk) via the desktop or mobile website:
