

"BEA Credit Card x foodpanda Promotional Offer" Terms and Conditions

- 1. This promotion runs from 1st June, 2023 till 16th July, 2023, both dates inclusive (the "Promotional Period").
- **2.** The Offer applies to cardholders of an eligible BEA credit card, except for BEA JCB PLATINUM card and BEA UnionPay Dual Currency Credit card and BEA Corporate Card ("Cardholders").
- **3.** The Offer applies to Cardholders of an eligible physical BEA credit card ("Eligible Credit Card"), transaction made by third party or e-wallet payment applications (including but not limited to Apple Pay, Google Pay, AlipayHK, WeChat Pay, PayPal, Payme) shall be excluded in the program. During the promotion period, cardholders who makes a purchase with eligible cards on foodpanda food delivery and/ or pick-up, through foodpanda official website (www.foodpanda.hk) and/ or mobile application and enter promotion code "BEA40" at checkout to enjoy HK\$40 instant discount on food delivery/ pick-up order with a single net spending of HK\$250 or above ("Offer").
- **4.** Cardholders must become a foodpanda member in order to enjoy the Offer.
- **5.** Each foodpanda member can enjoy the Offer maximum three times during the Promotional Period. Unless otherwise specified, only HKD transactions will be eligible for the Offers.
- **6.** Offer is on a first-come-first-serve basis, while stocks last. Quota of Promo Code is calculated based on the computer record of Merchant which shall be conclusive.
- **7.** A "single net spending" applies to the net amount of a single transaction after the exclusion of delivery fees, platform fees or other fees and deduction of all applicable discounts, reductions and vouchers. Other transactions, including but not limited to pandapro subscriptions and purchase of cash vouchers are not eligible.
- **8.** Offer cannot be used in conjunction with other promotion codes.
- **9.** Offer cannot be exchanged for cash or be refunded.
- **10.** No person other than the Cardholder, BEA and the Merchant will have any right under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong) to enforce or enjoy the benefit of any of the provisions of these Terms and Conditions.
- **11.**BEA makes no representation or guarantee as to the quality and availability of the products, services, or information provided by the Merchant. BEA shall not be liable for any matters arising from or in connection with the products, services, or information provided by the Merchant. Cardholders should direct any queries or complaints to the Merchant. Shall there be any further existence of claims or disputes between cardholders and the Merchant, BEA should be informed of such claims or disputes within a reasonable period so that BEA can make corresponding handling.
- **12.** BEA and the Merchant reserve the sole right to vary or cancel the promotion and/or amend or alter these Terms and Conditions at any time without prior notice. In the event of any dispute, the decision of BEA and the Merchant shall be final and conclusive.
- **13.** These Terms and Conditions shall be governed by and construed in accordance with the law of Hong Kong.
- **14.** If there is any inconsistency or ambiguity between the English and Chinese versions of these Terms and Conditions, the English version shall apply and prevail.
