

## "BEA Credit Card x KKday Year-round Offers" - Terms and Conditions

- 1. The promotion runs from 30<sup>th</sup> March to 31<sup>st</sup> December, 2023, both dates inclusive (the "Promotional Period"); itineraries have to be completed on or before 31<sup>st</sup> January, 2024, after which the offer will be invalid. Only **HKD** transactions will be eligible for the Offers.
