

"BEA Credit Card - KeyChain Pay Rental Payment Offer" - Terms and Conditions

- 1. The promotion runs from 4th October, 2023 to 31st August, 2024, both dates inclusive (the "Promotional Period").
- 2. The promotion only applies to the principal and supplementary cardholders (the "Cardholders"), who hold BEA MasterCard or MasterCard Co-branded Cards, excluding BEA Corporate Card ("Eligible Credit Cards"), issued by The Bank of East Asia, Limited ("BEA"), during the Promotional Period.
- Cardholders must use a valid BEA credit card to pay the rental fee at KeyChain Pay ("Merchant") during the Promotional Period in order to enjoy the Offer. Offer 1: Transaction Fee Offer

The Smart Contract requires a legitimate and stamped tenancy agreement that has not been used in KeyChain Pay to set up; and, set monthly rent on the Smart Contract at HK\$10,000 or above.
