

"Wing On Travel x BEA Credit Card Up to HK\$570 Instant Discount" - Promotion Terms and Conditions

1. This promotion runs from 1 April 2026 10:00am to 30 April 2026, both dates inclusive (the "Promotional Period"), or subject to Offer Quota usage status, whichever is earlier. Hotel stay period/ flight and Package departure date is from 1 April 2026 10:00am to 31 October 2026, both dates inclusive (excluding selected products), subject to the date that can be selected by the system.
2. The promotion only applies to the holders (the "Cardholders"), who hold a BEA Credit Card or co-branded card, excluding BEA JCB PLATINUM Card and corporate card ("Eligible Credit Cards"), issued by The Bank of East Asia, Limited ("BEA").
3. The promotion is applicable to Wing On Travel website (<https://www.wingontravel.com>) and Wing On Travel Mobile Application (collectively "Wing On Travel Platform"). Transactions made at Wing On Travel outlets are not eligible for this promotion.
