

"ZALORA Exclusive Shopping Offers" - Terms and Conditions

- 1. This promotion runs from 1st December, 2023 to 31st December, 2023, both dates inclusive (the "Promotional Period").
- 2. The promotion only applies to the cardholders (the "Cardholders"), who hold BEA Credit Cards or Co-branded/ Affinity Cards, excluding BEA Corporate Cards ("Eligible Credit Cards"), issued by The Bank of East Asia, Limited ("BEA"), during the Promotional Period. The promotion applies to supplementary cardholders. Cardholders must use a an Eligible Credit Card to pay in full at ZALORA (the "Merchant") Hong Kong website (www.zalora.com.hk) or mobile app during the Promotional Period in order to enjoy the following offers.
- 3. Offer 1: Extra HK\$40 instant discount with a net spending of HK\$600

To get an extra HK\$40 instant discount offer, Cardholders must reach a net spending of HK\$600 and enter the promo code "BEA40DEC" at checkout ("Offer 1"). Designated brand exclusions apply. The promo code is stackable on top of item-level vouchers, except Offer 2. Offer can be used maximum 3 times per Cardholder; Offer is subject to a quota and is available on a first-come, first-served basis.

Offer 2: Get extra 20% off and 5% rebate with a net spending of HK\$499

To get an extra 20% off and 5% rebate to ZALORA Wallet ("5% Rebate") offer, Cardholders must reach a net spending of HK\$499 and enter the promo code "BEA20CB" at checkout ("Offer 2"). Offer applies to items sold by ZALORA only and non-stackable to other offers; the extra 20% off cannot exceed HK\$120 per transaction. BEA shall not be liable for any matters arising from or in connection with the products, services, or information provided by the Merchant. Cardholders should direct any queries or complaints to the Merchant. Shall there be any further existence of claims or disputes between cardholders



- and the Merchant, BEA should be informed of such claims or disputes within a reasonable period so that BEA can make corresponding handling.
- 11. BEA and the Merchant reserve the sole right to vary or cancel the Offer and/or amend or alter these Terms and Conditions at any time without prior notice. In the event of any dispute, the decision of BEA and the Merchant shall be final and conclusive.
- 12. These Terms and Conditions shall be governed by and construed in accordance with the law of Hong Kong. You submit to the non-exclusive jurisdiction of the Hong Kong courts but these Terms and Conditions may be enforced in the courts of any competent jurisdiction.
- 13. If there is any inconsistency or ambiguity between the English and Chinese versions of these Terms and Conditions, the English version shall apply and prevail.
