

"BEA Credit Card – hutchgo HK\$300 Instant Discount Offer" - Promotion Terms and Conditions

- 1. This promotion runs from 2 July 2025 to 15 August 2025, both dates inclusive (the "Promotional Period"), or subject to Offer Quota usage status, whichever is earlier. The travel period is from 3 July 2025 to 31 January 2027 (both dates inclusive), subject to the date that can be selected by the system.
- 2. The promotion only applies to the cardholders (the "Cardholders"), who hold BEA Credit Cards or Cobranded Cards, excluding BEA Corporate Card ("Eligible Credit Cards"), issued by The Bank of East Asia, Limited ("BEA").
- 3. Offer is applicable to Hutchison Travel Limited (the "Merchant") website (www.hutchgo.com.hk) and mobile app (collectively "hutchgo Platform").
