 - i. successfully applied and submitted (based on the application date) during the Promotion Period, and
 - ii. issued on or before 29 February 2024.
4. The calculation of the premium refund is only applicable to the standard premium and extra premium due to underwriting (if any) of the New Policy. The calculation of the premium discount is only applicable to the standard premium (extra premium due to underwriting (if any) is excluded) of the New Policy.
