## **Auto-Payroll Promotion Terms and Conditions**

### **A. General Terms and Conditions**

1. The offer (the "Offer") is valid from 1<sup>st</sup> October to 31<sup>st</sup> December, 2024, (both days inclusive) (the "Promotional Period"), unless otherwise specified.
2. The Offer only applies to new auto-payroll customers ("Eligible Payroll Customers") who:
  - (i) register their individual all-in-one account including a SupremeGold Private Account, SupremeGold Account, Supreme Account or BEA GOAL (the "Payroll Account") held with The Bank of East Asia, Limited ("BEA") for the payroll service during the Promotional Period; and
  - (ii) authorise their employer to disburse their monthly salary through automated payroll payment into their Payroll Account in the designated payroll period in respect of the registration month as set out in Clause B1 below.
  - (iii) Where applicable, who is employee of a company which has been registered for Employee Benefit Scheme ("Employee Benefit Scheme Customers") and is required to present his/her company staff card/employment name card/ contract or any relevant proof from the employer at the time of payroll registration at branch;

For the avoidance of doubt, customers who are under any of the following conditions at any time in the past 12 months prior to the Promotional Period will not be regarded as Eligible Payroll Customers:

- (i) registered BEA's payroll service or ;
  - (ii) received automated payroll payment in their Payroll Account or;
  - (iii) received a reward in a previous BEA payroll promotion
3. Eligible Payroll Customer with "Talents to Hong Kong" identity ("Eligible Talent Customer") (as depicted in 3.1 to 3.3 below ) would enjoy bonus offers, offer details are stipulated in part B, C below.
  - 3.1. "Talents to Hong Kong" includes the following schemes: (i) " Top Talent Pass Scheme "; (ii)" Immigration Arrangements for Non-local Graduates "; (iii) " Quality Migrant Admission Scheme "; (iv) " Technology Talent Admission Scheme ", the scope of the schemes will be from time to time, please contact the BEA staff for details. The Bank reserves the right to make the final decision as to whether a customer is an Eligible Talent Customer.
  - 3.2. Eligible talent customer must provide proof of "Talents to Hong Kong" for application, including but not limited to the designated schemes reversed in the point 3.1. The scope of required supporting documents will be announced by BEA from time to time. For details, please contact BEA branch staff.
  - 3.3. Eligible talent customer must indicate their "Talents to Hong Kong" identity to BEA branch staff and BEA branch staff will update their customer information accordingly.
4. Quotas of the Offer are available on a first-come-first-served basis while quota lasts.
5. Deposits through Standing Instructions, CHATS, telegraphic transfers, cash, or cheque deposits are not acceptable as automated payroll payments. All auto-payroll transaction records are determined according to BEA's record. In the event of any dispute, the decision of BEA shall be final and conclusive.
6. Each Eligible Payroll Customer is required to register once by completing "BEA Auto-Payroll Promotion Registration Form" at branch or "Online Registration Form for Payroll Promotion" via BEA website during the Promotional Period (registration via BEA website is not applicable to Employee Benefit Scheme Customers). Should duplicated registration records be found, only the first record the customer has made with BEA shall prevail. If the registered payroll account is a joint-account, the Offer would only make applicable to the primary account holder. No registration records can be altered subsequently, and BEA's record shall apply and prevail.
7. Each Eligible Payroll Customer is entitled to receive the rewards stipulated in Part B and Part C (where applicable) of this Terms and Conditions once only during the Promotional Period.
8. The Eligible Payroll Customer must hold a Payroll Account with normal account status (to be determined by BEA) in BEA's records at the time during the Promotional Period and BEA credits the reward(s). If the customer closes any of the aforesaid accounts and/or cancels any of the aforesaid services on or before the date when the reward(s) is/are credited, the customer's entitlement to the reward(s) will be forfeited.
9. The Offer is non-redeemable and non-transferrable, and cannot be used in conjunction with other "Auto-Payroll Promotion" offers, the promotion that the customer registered first shall prevail.

10. Employees of any member of the BEA Group are ineligible to join this promotion.
11. BEA reserves the right at its sole discretion to determine the calculation methods (including but not limited to ascertaining the payroll amount, number of payroll transactions, and the amount of any applicable account deposit balance) applied to the Offer under this promotion, and to verify eligible customers' transaction records for the purposes of the promotion. The Offer is determined by BEA's computer records and data. In case of any disputes, BEA's decision shall be final and binding.
12. BEA reserves the sole right to vary or extend or terminate the Offer and/or amend or alter these terms and conditions at any time without prior notice. In the event of any dispute, the decision of BEA shall be final and conclusive.
13. No person other than the Eligible Customer or BEA will have any right under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong) to enforce or enjoy the benefit of any of the provisions of these Terms and Conditions.
14. These Terms and Conditions are governed and construed under the jurisdiction of the Hong Kong Special Administrative Region.
15. For Employee Benefit Scheme Customers, whether the employer is considered to be Selected or VIP Employee Benefit Scheme customer to the bank, is solely determined by the bank.
16. If there is any discrepancy between the English and Chinese versions of these terms and conditions, the English version shall apply and prevail.

## B. Terms and Conditions of Basic Cash Rebate

1. By fulfilling all below conditions, Eligible Payroll Customer (including Eligible Talent Customer) can obtain a cash rebate.
  - (i) Successfully register for Auto-Payroll with BEA through the method stipulated in Clause A6 above within the Promotional Period to become an Eligible Payroll Customer, and
  - (ii) Have at least 3 months of payroll record of specified amount (as set out in Table 1 below) in Eligible Payroll Customer's Payroll Account during the Payroll Period according to the auto-payroll registration month as set out in Table 2 below.
  - (iii) Complete at least 1 of the below 2 designated transactions ((a)-(b)) within the designated transaction period according to the auto-payroll registration month as set out in Table 2 below
    - (a) Set up a direct debit authorization with the Payroll Account.
    - (b) Set the Payroll Account as the Faster Payment System ("FPS") Default Account.

2. The cash rebate will be credited to Eligible Payroll Customer's HKD Savings Account under Payroll Account without prior notice.

## C. Terms and Conditions of Bonus Interest Rate Offer ("Bonus Interest Rate")

1. Bonus Interest Rate is only applicable to Eligible Talent Customers & Employee Benefit Scheme Customers.

2. Eligible Talent Customers & Employee Benefit Scheme Customers of different Employee Benefit Scheme type would enjoy Bonus Interest Rate and the Bonus Interest Rate on top of BEA's HKD Savings rates only applies to the designated deposit balances of the HKD Current Account under Payroll Account ("Designated Account") as set out in Table 3 below. The Bonus Interest Rate is indicative and subject to change at the sole discretion of BEA.

\*The HKD Savings Rate is 0.625% p.a. which is quoted on 20<sup>th</sup> September, 2024 and may change from time to time at the Bank's sole and absolute discretion.

3. Eligible Talent Customers & Employee Benefit Scheme Customers who successfully registered Auto-Payroll with BEA according to the Auto-Payroll Registration date as set out in Table 4 below will entitle a Bonus Interest Rate Period of 6 months ("Bonus Interest Rate Period") for the HKD Current Account under Payroll Account as stipulated in Clause A2 ("Designated Account").

4. The Bonus Interest Rate applies to the day-end balance of the Designated Account. The deposit balance of the Designated Account shall be determined according to BEA's record.
5. The Bonus Interest Rate will be calculated as simple interest and on the basis of 365 days (for both common years and leap years). Interest will be credited to the Designated Account once per month, on the first business day of each month. The balance, the interest calculation and the interest credited of the Designated Account are determined by BEA's computer records and data. In case of any disputes, BEA's decision shall be final and binding.
6. The deposit rate (including the Bonus Interest Rate) will not apply to the deposit balance in the Payroll Account after the end of the Bonus Interest Rate Period.
7. All interest rates are subject to change due to market fluctuations, BEA will provide prior notice before the change of deposit interest rate.
8. If the Designated Account is suspended or terminated during the Bonus Interest Rate Period, Eligible Talent Customer will no longer be eligible to the Bonus Interest Rate.
9. Unless otherwise specified, the Bonus Interest Rate cannot be used in conjunction with other deposit promotional offers during the Promotional Period. BEA reserves the right to grant the customer one of Bonus Interest Rate offer to which they are entitled.

## 自動轉賬支薪推廣條款及細則

### A. 一般條款及細則

1. 除非另有註明，此優惠（「優惠」）之推廣期由2024年10月1日至12月31日（包括首尾兩天）（「推廣期」）。
  2. 本推廣只適用於符合以下要求之全新自動轉賬支薪客戶（「合資格支薪客戶」）：
    - (i) 於推廣期內於東亞銀行有限公司（「本行」）透過其以個人名義持有之顯卓私人理財戶口、顯卓理財戶口、至尊理財戶口、或BEA GOAL（「支薪戶口」）綜合戶口登記本行自動轉賬支薪服務；及
    - (ii) 授權其僱主以自動轉賬支薪方式於相對月份（見條款B1之列表2）進誌薪金至支薪戶口
    - (iii) 如適用，已登記僱員優惠計劃之公司的僱員（「僱員優惠計劃客戶」），並須於本行分行登記優惠同時出示閣下所屬公司的有效職員証、名片、僱傭合約或公司發出的証明

3. 合資格支薪客戶中的「人才來港」客戶（「合資格人才客戶」）（根據下列3.1至3.3所定義）會獲享額外優惠，優惠詳情見B、C部分。
    - 3.1. 「人才來港」包括(i)「高端人才通行證計劃」、(ii)「非本地畢業生留港／回港就業安排」、(iii)「優秀人才入境計劃」及(iv)「科技人才入境計劃」。「人才來港」範圍不時修訂，詳情請向本行職員查詢。本行就客戶是否屬合資格客戶保留最終決定權。
    - 3.2. 合資格人才客戶必須提供「人才來港」證明文件以作出申請，包括但不限於第 3.1 點提及之指定入境簽證。所需證明文件範圍按本行不時公佈為準，詳情可與本行職員查詢。

  5. 自動轉賬支薪方式不包括以定期轉賬指示方式、經電子過賬系統或電匯轉賬之存款、現金及支票存款。所有自動轉賬支薪交易以本行系統錄得的最終交易記錄為準，如有爭議，本行保留最終決定權。
  6. 每位合資格支薪客戶只須於推廣期內透過本行填妥「東亞銀行自動轉賬支薪推廣登記表格」或透過本行網頁填妥「轉賬支薪推廣網上登記表格」登記1次(網頁登記不適用於僱員優惠計劃客戶)。如有重複登記，本行會以客戶之首次登記記錄為準。若登記戶口為聯名戶口，所有優惠則只適用於第一賬戶持有人。所有登記恕不能更改，並以本行記錄為準。
  7. 每位合資格支薪客戶於推廣期內只可享有本條款B及C部分所列的獎賞及優惠1次。

  14. 本條款及細則受香港特別行政區法律所管轄，並按照香港特別行政區法律詮釋。
  15. 就僱員優惠計劃客戶之僱主是否為界定為特選僱員優惠計劃客戶，全由本行決定。

16. 此等條款及細則之中英文版本如有歧異，以英文版本為準。

## B. 基本現金回贈之條款及細則

## C. 額外儲蓄存款年利率(「額外年利率優惠」)之條款及細則
