

## Terms and Conditions for Risk Assessment Questionnaire Reward for Cross-boundary Customers

- 1. The Reward (as defined in Clause 7 below) is valid from 1 October till 31 October, 2025, both days inclusive (the "Promotion Period").
- 2. Cross-boundary ("CB") Customers are defined as customers i) Holding Hong Kong Non-Permanent Identity Card and Nationality of Chinese, or ii) Holding Non-Hong Kong Identity Card, or iii) with Non-Hong Kong Residential Address.
- 3. "WMC" refers to Cross-boundary Wealth Management Connect (Southbound).
- 4. The Reward only applies to "Designated Activity" (as defined in Clause 7 below) made by New-to-investment Customers (as defined in Clause 5 below) or Selected Customers (as defined in Clause 6 below) (Collectively, the "Eligible Customers") of The Bank of East Asia, Limited ("BEA") who have successfully opened or maintained a SupremeGold Private or SupremeGold Account.
- 5. "New-to-investment Customers" refers to a CB or a WMC customer who has not maintained any investment accounts with BEA, either individually or jointly, from 1 October 2024 to 30 September 2025.
- 6. "Selected Customers" refers to an existing BEA CB or WMC customer who has maintained investment account(s) with BEA, either individually or jointly, from 1 October 2024 to 30 September 2025.

Eligible Customers will receive HK\$200 or HK\$100 cash reward upon completing the Risk Assessment Questionnaire (the "RAQ") via any BEA Branch, BEA Online or BEA Mobile ("Designated Activity") during the Promotion Period. In order to be eligible for the Reward, Eligible Customers must newly complete the RAQ or must not have a valid RAQ when they complete the RAQ during the promotional period.
