

## BEA Account Opening Attestation Service Remittance Handling Fee Waiver Terms and Condition

Customers applied Mainland Personal Type II Bank Account via The Bank of East Asia, Limited ("BEA Hong Kong") "BEA Account Opening Attestation Service" can enjoy outward remittance fee ("Handling Fee") waiver when remitting funds to their same name Type II accounts held with Bank of East Asia (China) Limited in the Mainland ("Designated Customers").

- 1. The Handling Fee waiver is valid from 1<sup>st</sup> Jan 2025 to 30<sup>th</sup> Jun 2025 (both days inclusive) (the "Promotion Period"), unless otherwise specified.
- 2. BEA Hong Kong and BEA China refer to "The Bank of East Asia, Limited" and "The Bank of East Asia (China) Limited" respectively, and BEA China is a wholly-owned subsidiary of BEA Hong Kong incorporated in the Mainland.
- 3. "BEA Account Opening Attestation Service" refers to customers applied Mainland Personal Type II Bank Account via BEA Hong Kong.
- 4. The above Handling Fee waiver is applicable to Designated Customers.
- 5. Designated Customers who meet all of the following conditions for outward remittance can enjoy the Handling Fee waiver:
  - The remittance currency must be RMB; and
  - The account name of the beneficiary must be the same as the Designated Customer (Remitter); and
  - The beneficiary bank is BEA China's mainland branch/sub-branch. (The first 6 digits and the 9th and 10th digit of the account card number are: 622933XX96XXXXXXXXX).
- 6. Designated Customers who make remittance through BEA Hong Kong Branch can immediately waive the Handling Fee; Designated Customers who make remittance through Cyber Banking or Mobile Banking required to pay the relevant Handling Fee upfront according to their remittance instructions. The relevant Handling Fee will be credited to the Designated Customer's Hong Kong Dollar savings account under the BEA Hong Kong personal banking account in the form of cash rebate on or before 31st Aug 2025. BEA Hong Kong will not give prior notice.
- 7. If the Designated Customer cancels the aforementioned account and/or service on or before the date of the handling fee waiver rebate, his/her eligibility for Handling Fee waiver will be cancelled.
- 8. The waived Handling Fee is limited to the basic handling fee for outgoing remittance transactions (including telegraphic transfer fee, cable charge and correspondent bank fee). If it involves other fees not charged by BEA Hong Kong to the designated customers, the handling fee waiver is not covered.
- 9. All Handling Fee waivers are non-transferable and cannot be used in conjunction with any other waivers.
- 10. BEA Hong Kong reserves the right to offer only one or part of the Handling Fee waiver if the Designated Customers are entitled to other waivers during the promotion period.
- 11. BEA Hong Kong reserves the right to amend, suspend or terminate the above waiver, and to amend the relevant terms at any time at its sole discretion. In case of any dispute, the decision of BEA Hong Kong shall be final.
- 12. Should there be any discrepancy between the English and Chinese versions of this promotion material, the Chinese version shall prevail.
