

Cooling-off Period for Card and Unsecured Loan Products

To allow customers to have sufficient time to reconsider their financial commitments, the Bank provide customers a 7 days' cooling-off period to Card and Unsecured Loan Products. Customers can cancel and fully repay their loan within this period without incurring any interest or fees.

FAQ

1. Cooling-off period duration

- Loan is cancelled and the facility is fully repaid within 7 calendar days immediately following the date of drawdown of the loan
- Example: If the loan is drawdown on 2 July 2025, the Cooling-off period duration will be from 2 July 2025 to 9 July 2025

2. Eligible loan products

- Unsecured Personal Instalment Loan Products (including Tax Season Loan, "Super-Fast" Instalment Loan, Top up Loan and Debt Clearance Plan)
- Overdraft Facility
- Revolving Loan
- Card Loan (including "Cash in Hand" Programme, "Cash in Hand" Statement Instalment Programme, "Cash in Hand" Balance Transfer Programme, "Pay My Way" Auto Instalment Programme)

3. Loan cancellation request channels

Customers must submit a loan cancellation request within the cooling-off period through the below designated channels

4. Interest and charges during cooling-off period

- Any disbursed loan amount must be repaid in full to the bank
- No interest or fee will be imposed if the loan is cancelled and fully repaid within the cooling-off period

常問問題

1. 冷靜期期限

- 在提取貸款後的7個曆日內取消並全額償還貸款
- 例子: 如果貸款於 2025 年 7 月 2 日提取,冷靜期期限為 2025 年 7 月 2 日至 2025 年 7
 月 9 日

2. 符合貸款產品

- 無抵押個人分期貸款產品(包括稅季貸款、「勁快」分期貸款、加借貸款和清數計劃)
- 透支服務
- 循環貸款
- 信用卡貸款(包括「好用錢」現金兌現計劃、「好用錢」結單分期計劃、「好用錢」 結餘轉戶計劃和「Pay My Way 」自動分期計劃)
