Notice: Maximum daily transaction limits through Cyberbanking and the BEA App for various account types

With effect from 16<sup>th</sup> March, 2020, the deposit limit on fund transfers will no longer be available in Cyberbanking and the BEA App. The current daily limits for maximum transaction amounts will remain unchanged. Please find the details below.
