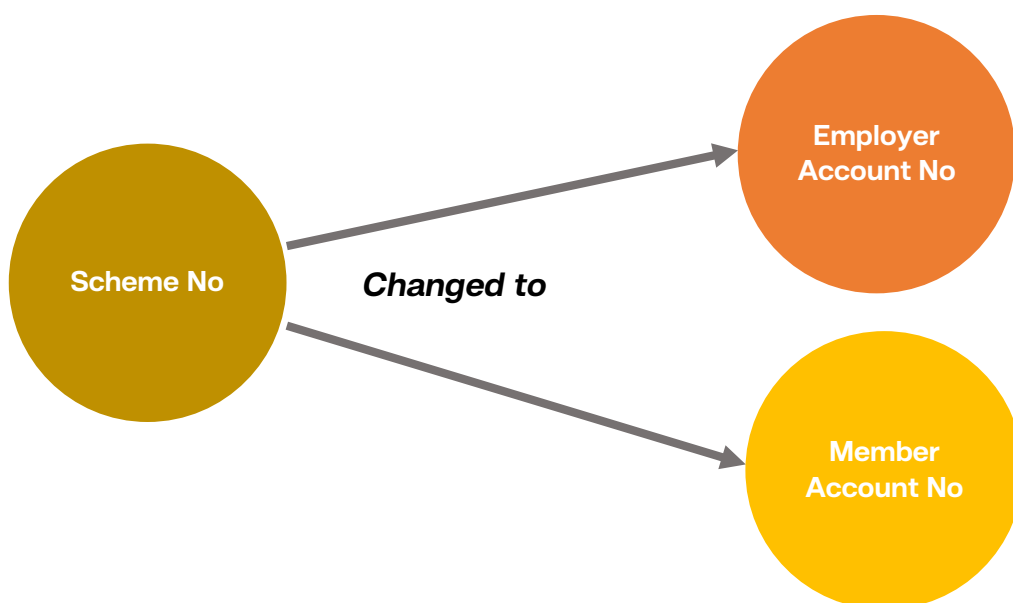

## Invitation to Employers Regarding the Abolition of MPF Offsetting Arrangement Seminar

According to the Employment and Retirement Schemes Legislation (Offsetting Arrangement) (Amendment) Bill 2022 on 9th June 2022 to abolish the use of the accrued benefits of employers' mandatory contributions under the Mandatory Provident Fund (MPF) System to offset Severance Payments (SP) and Long Service Payments (LSP) (the offsetting arrangement). The Government will implement the abolition of the offsetting arrangement effect on 1st May, 2025.

In order to help employers to know more about the "offsetting" arrangement, we will be holding a seminar and inviting the Labour Department representative to share key information about these arrangements and answer your questions.
