Following the successful onboarding of the BEA (MPF) Master Trust Scheme and BEA (MPF) Value Scheme to the eMPF Platform ("the Platform"), the **BEA (MPF) Industry Scheme** will also be onboarded to the Platform on **30<sup>th</sup> April, 2026**, and registration began on **22<sup>nd</sup> December 2025**. Subsequently, the administration of the BEA (MPF) Industry Scheme will be performed by the Platform.
