

Terms and conditions for 25 Basis Points Annualised Interest Rate Discount Offer

- 1. This 25 basis points annualised interest rate discount ("Discount Offer") is applicable to a corporate customer ("Eligible Customer") who have successfully applied for BEA's Enterprise Easy Fund Unsecured loan or Energy Efficiency Loan from 1 July 2025 to 30 September 2025 (both dates inclusive), and completed full loan drawdown on or before 31 December 2025.
- 2. Each Eligible Customer enjoy Discount Offer once only. BEA has the sole discretion to determine which application shall be eligible (in case of multiple applications). Approval of application is subject to the Bank's credit policy and other relevant criteria.
- 3. Any false or erroneous redemption whether due to clerical error, system malfunction, fraudulent activity, misrepresentation, or any other reason, the Bank reserves the right to immediately cease the application of the discount and to recover the full value including but not limited to direct debit from the applicant's account(s) held with the Bank, demand for immediate repayment, and legal action. The discounted amount recoverable shall be equal to the total value of the interest reduction wrongly applied to the loan from the date of the erroneous redemption, and the Bank has the sole discretion on methodology of calculation.
- 4. By participating in the campaign, Eligible Customer agrees to be bound by these terms and conditions.
- 5. BEA reserves the rights to suspend, amend or terminate the above Discount Offer and to amend the relevant terms and conditions at any time at its sole discretion without prior notice.
- 6. These terms and conditions are governed by and construed under the law and regulatory requirements of the Hong Kong Special Administrative Region.
- 7. No person other than the Eligible Customer or the Bank will have any right under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong) to enforce or enjoy the benefit of any of the provisions of these terms and conditions.
- 8. If there is any discrepancy between the English and Chinese versions of these terms and conditions, the English version shall apply and prevail.
- 9. In the event of any discrepancy between information presented in the promotional materials and these Terms and Conditions, these Terms and Conditions shall take precedence and govern.



25 點子全期貸款年利率折扣之條款及細則
