

## **Terms & Conditions for BEA GOAL Account Deposit Balance Growth Promotion**

## A. General Terms and Conditions

- 1. This promotion is from 1<sup>st</sup> July, 2023 to 30<sup>th</sup> September, 2023 (both dates inclusive) (the "Promotional Period").
- 2. HK\$100 Cash Rebate on Incremental Deposit Balance and HK\$6,000 Cash Rebate Lucky Draw (the "Offers") are only applicable to customers who maintain a BEA GOAL account with The Bank of East Asia, Limited ("BEA") (the "BEA GOAL Customers") and fulfil the respective requirements of each Offer.
- 3. "Eligible Deposit Balance" refers to the sum of daily balance under the Current, Savings and Time Deposit accounts (including HKD and foreign currency) under the BEA GOAL account.
- 4. BEA will use the exchange rate of month-end (as determined by BEA at its sole discretion) to calculate the HKD equivalent of any deposits in foreign currency accounts in order to determine the month-end Eligible Deposit Balance.
- 5. For joint accounts, only the primary account holder is entitled to receive the Offers.
- 6. The Offers will only be awarded to Eligible Customers (as defined in Section B Clause 2) whose BEA GOAL Account is valid when the Offers are credited. Otherwise, eligibility to receive the Offers will be forfeited.
- 7. If the BEA GOAL account of Eligible Customers is closed prior to the Offers being credited, the Offers will be forfeited.
- 8. All offers are non-redeemable and non-transferrable, and cannot be enjoyed in conjunction with any other promotional offers.

BEA reserves the right to determine, at its sole discretion, the calculation methods of the Offers under this promotion (including in ascertaining the amount of any applicable account deposit balance), the customers' eligibility, and the result and details of the Lucky Draw (as defined in Section C) according to the records and data in BEA's computer systems.
- 11. BEA reserves the sole right to vary or cancel all or any of the offers and/or amend or alter these Terms and Conditions at any time without prior notice. In the event of any dispute, the decision of BEA shall be final and conclusive.
- 12. No person other than the Eligible Customer or BEA will have any right under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong) to enforce or enjoy the benefit of any of the provisions of these Terms and Conditions.
- 13. These Terms and Conditions are governed and construed under the jurisdiction of the Hong Kong Special Administrative Region.
- 14. Should there be any discrepancy between the English and Chinese versions of these Terms and Conditions and the Offers, the English version shall apply and prevail.

## B. HK\$100 Cash Rebate on Incremental Deposit Balance ("Incremental Offer")

 The Offer will run in 3 phases based on the date of BEA GOAL Customers who are holding a valid BEA GOAL account.

2. To be eligible for Incremental Offer, the month-end Eligible Deposit Balance must be higher than the previous month's month-end Eligible Deposit Balance by HK\$1,000 or above for consecutive 6 months within the Deposit Balance Review Period per below table in each phase. BEA GOAL Customers who have fulfilled this requirement (the "Eligible Customers") will be eligible to receive the Incremental Offer, which will be credited to BEA GOAL HKD Savings Account of the Eligible Customers according to below table without prior notice.
