After you have consented to receiving future Corporate Communications in electronic form by accessing the Website Version (the "Consent"), you will still be entitled to (i) request printed copies of the relevant Corporate Communications free of charge; or (ii) revoke the Consent at any time by giving reasonable notice in writing to the Share Registrar specifying your request together with your full name and contact phone number.

You do not need to complete Box A of the Reply Form if you wish to continue to receive printed copies of future Corporate Communications.

Solicitation of Electronic Contact Details

Please note that the Bank is required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited to send Actionable Corporate Communications to Shareholders individually in electronic or printed form. For the 2024 Second Interim Scrip Dividend Scheme, the relevant form of election or, if you have previously given a permanent election instruction, the notification letter has been sent to you in electronic form by email or in printed form.

If you have not provided your email address to the Bank or need to update your email address for the purpose of receiving future Actionable Corporate Communications (or other Corporate Communications as the Bank may decide from time to time) in electronic form, we recommend you to provide/update your email address to the Bank by completing Box B of the Reply Form and returning the Reply Form to the Share Registrar^{Note 3}. If you do not provide your email address in the Reply Form or the email address provided is not functional, the Bank will only be able to send future Actionable Corporate Communications to you in printed form.
