## PAYMENT OF SECOND INTERIM DIVIDEND (IN LIEU OF FINAL DIVIDEND) FOR 2013

The Board of The Bank of East Asia, Limited (the "**Bank**") has declared a second interim dividend (in lieu of final dividend) for the year ended 31<sup>st</sup> December, 2013 of HK\$0.68 per share ("**2013 Second Interim Dividend**") (2012 second interim dividend (in lieu of final dividend): HK\$0.63 per share), which, together with the interim dividend of HK\$0.43 per share paid in September 2013, will constitute a total dividend of HK\$1.11 per share (2012: HK\$1.06 per share) for the full year. The 2013 Second Interim Dividend will be paid on or about Wednesday, 2<sup>nd</sup> April, 2014 in cash with an option to receive new, fully paid shares in lieu of cash, to shareholders whose names appear on the Register of Members at the close of business on Tuesday, 11<sup>th</sup> March, 2014 ("**Scrip Dividend Scheme**"). Details of the Scrip Dividend Scheme and the election form will be sent to shareholders on or about Tuesday, 11<sup>th</sup> March, 2014.

- (a) For the purpose of determining shareholders who qualify for the 2013 Second Interim Dividend, the Register of Members of the Bank will be closed on Monday, 10<sup>th</sup> March, 2014 and on Tuesday, 11<sup>th</sup> March, 2014. In order to qualify for the 2013 Second Interim Dividend, all transfer documents should be lodged for registration with Tricor Standard Limited\* by 4:00 p.m. on Friday, 7<sup>th</sup> March, 2014.
- (b) For the purpose of determining shareholders who are entitled to attend and vote at the 2014 AGM, the Register of Members of the Bank will be closed from Wednesday, 30<sup>th</sup> April, 2014 to Friday, 2<sup>nd</sup> May, 2014 (both days inclusive).
