## PAYMENT OF SECOND INTERIM DIVIDEND FOR 2014

The Board of The Bank of East Asia, Limited (the "**Bank**") has declared a second interim dividend for the year ended 31<sup>st</sup> December, 2014 ("**2014 Second Interim Dividend**") of HK\$0.68 per share (2013 Second Interim Dividend: HK\$0.68 per share), which, together with the interim dividend of HK\$0.43 per share paid in September 2014, will constitute a total dividend of HK\$1.11 per share (2013 total dividend: HK\$1.11 per share) for the full year. The 2014 Second Interim Dividend will be paid on or about Friday, 27<sup>th</sup> March, 2015 in cash with an option to receive new, fully paid shares in lieu of cash ("Scrip Dividend Scheme"), to shareholders whose names appear on the Register of Members of the Bank at the close of business on Thursday, 5<sup>th</sup> March, 2015. The ex-dividend date for 2014 Second Interim Dividend will be on Monday, 2<sup>nd</sup> March, 2015. Details of the Scrip Dividend Scheme and the election form will be sent to shareholders on or about Thursday, 5<sup>th</sup> March, 2015.
