Mr. Kwok Siu Man has been nominated by a shareholder for election as an independent non-executive director of the Bank. A resolution will be considered at the AGM of the Bank to be held on Thursday, 16th April, 2009, with respect to the appointment of Mr. Kwok Siu Man as an independent non-executive director of the Bank, such appointment to be conditional upon the Bank receiving written consent from the Hong Kong Monetary Authority in respect of Mr. Kwok's appointment.

Accordingly, the Bank hereby put forward that, in addition to the nine resolutions proposed to be considered and, if thought fit, approved at the AGM, the following resolution will be considered and, if thought fit, approved at the AGM:

10. To appoint Mr. Kwok Siu Man as an independent non-executive director of the Bank, such appointment to be conditional upon the Bank receiving written consent from the Hong Kong Monetary Authority for Mr. Kwok Siu Man to act as a director of the Bank.

The details of the biography of Mr. Kwok Siu Man ("Mr. Kwok") are set out below:

Mr. Kwok FCIS, FCS, FFA, MCIArb, AHKIArb, ATIHK, MHKSI, AHKIHRM, RFP, PgD, CPE, BA, PD, aged 50, is currently the vice president and a director of Lam Kin Chung Morning Sun Charity Fund. He is also the company secretary of S E A Holdings Limited (stock code: 00251, a subsidiary of which is listed on the AIM Market of London Stock Exchange plc). Mr. Kwok holds a bachelor's degree of arts in accountancy and a post-graduate

diploma in laws. He is a member of the Hong Kong Securities Institute and a fellow member of The Hong Kong Institute of Chartered Secretaries ("HKICS"), The Institute of Chartered Secretaries and Administrators and The Institute of Financial Accountants in England. He also possesses other professional qualifications in arbitration, tax and human resources management.

Mr. Kwok was the company secretary of Great Eagle Holdings Limited (stock code: 00041), K. Wah International Holdings Limited (stock code: 00173), Sing Tao Holdings Limited (stock code: 00233, which became Sing Tao News Corporation Limited with stock code: 01105) and Thoresen & Co., Ltd. (a ship chartering and trading company). He also held directorship/senior managerial positions with subsidiaries of certain of the above companies. He was a director of a private property management company and co-founded a firm which provides accounting, tax, company secretarial and business consultancy services. Mr. Kwok has a total of approximately 25 years of corporate secretarial experience. Through his roles with the above companies, he also acquired experiences in management, business development, financial printing, insurance agency, investor relations and legal services. Mr. Kwok has not held any directorship position in publicly listed companies in the last three years.

Mr. Kwok is currently the longest-serving director and council member of the HKICS and its predecessor. He was a founding member of its Company Secretaries Panel and an adviser for "Hong Kong Company Secretarial Practice" of HKICS's qualifying examinations. He was nominated by the HKICS as a candidate for membership of the selection committee of the first Chief Executive of Hong Kong in 1996/1997. He received recognition in 1999 from an international organization which establishes a network of international professionals. Mr. Kwok is also a member of the Board of Review (Inland Revenue Ordinance of Hong Kong) and has acted as an external examiner to recognised academic and vocational institutions for corporate management courses and was a reviewer of a book in professional management and economics.

Mr. Kwok does not hold any position with the Bank or with other members of the Bank's group. He is not and was not connected with any director and senior management of the Bank.
