### GRANT OF SHARE OPTIONS

On 5<sup>th</sup> May, 2011, the Bank granted 5,950,000 share options to subscribe for Shares to certain Eligible Persons (as defined in the rules of the Scheme), out of which 2,000,000 share options were granted to the Chief Executive of the Bank.

This announcement is made pursuant to Rule 17.06A of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors of The Bank of East Asia, Limited (the "**Bank**") announces that on 5<sup>th</sup> May, 2011, the Bank granted 5,950,000 share options to subscribe for ordinary shares of HK\$2.50 each of the Bank ("**Shares**") under its Staff Share Option Scheme adopted on 19<sup>th</sup> April, 2011 (the "**Scheme**") to certain Eligible Persons (as defined in the rules of the Scheme). Details of such grant are set out below:

Out of the 5,950,000 share options, 2,000,000 share options were granted to Dr. the Hon. Sir David Li Kwok-po as Chief Executive of the Bank. The granting of the share options to the Chief Executive was approved by all the Independent Non-executive Directors of the Bank.
