2. EXTENSION OF THE TERM OF THE EMPLOYMENT CONTRACT OF EXECUTIVE CHAIRMAN

The Bank is pleased to announce that the existing employment contract of Dr. the Hon. Sir David LI Kwok-po as Executive Chairman of the Bank (the “**Employment Contract**”), which will expire on 30th June, 2022, has been extended for a further term of 3 years commencing on 1st July, 2022 and will expire on 30th June, 2025. The extension of the term of the Employment Contract has been endorsed by the Nomination Committee and approved by the Board of Directors of the Bank.
