Through building an instant, direct and effective communications mechanism between the Hong Kong Monetary Authority ("HKMA"), the Hong Kong Police Force ("HKPF") and participating banks, and allocating colleagues at ADA to conduct case investigation, freeze accounts, trace funds and share intelligence information, BEA strives to enhance capabilities and efficacy in fighting against deception.

BEA has been adopting new technologies and measures, and allocating additional resources for customer protection.
