

Terms & Conditions for Purchase Bonus Points ("Offer"):

- 1. The Offer is valid from 29 May 2020 to 30 June 2020, both dates inclusive ("Promotion Period").
- 2. Unless otherwise specified, the promotion only applies to cardholders ("Cardholders") who use BEA Credit Card ("Cards") issued by The Bank of East Asia Limited ("BEA") to pay for Bonus Points purchase.
- 3. To enjoy the Offer, the Cardholder is required to successfully register through 3608-6628 and provide a valid Card Number, an Asia MilesTM membership number with the same registered family name and given name under the same Cardholder, the number of Bonus Points to purchase.
