

## MCL Cinemas 2D e-Gift Voucher Terms and Conditions

- 1. MCL Cinemas 2D e-Gift Voucher ("e-Gift Voucher") will be granted to the eligible Cardholders, in the form of a redemption email together with codes. The redemption email together with the codes will be sent to the principal Cardholder's email address or texted to their mobile number (as registered in BEA's records). Eligible Cardholders are required to bring along the redemption email and principal credit card to redeem the movie ticket. When the movie ticket is redeemed, the merchant's retail outlet staff will cancel the validity of the codes in the redemption email. Eligible Cardholders will thereafter not be able to claim the movie ticket with that redemption email and/or codes. Eligible Cardholders need to follow the terms and conditions set by participating merchant when they use the e-Gift Voucher. Eligible Cardholders who fail to redeem the e-Gift Voucher within the valid period shall be regarded as having waived their entitlement to the e-Gift Voucher. Further details and terms and conditions of redemption of the e-Gift Voucher will be set out in the redemption email.
- 2. The redemption email together with codes can be used to claim one 2D movie ticket at the box office of any MCL Cinemas. Eligible Cardholders may visit MCL Cinemas' website for cinema information.
- 3. Cross-site ticketing service is not available at box office in MCL Cinemas.
- 4. The e-Gift Voucher is not redeemable through MCL Cinemas' website, mobile application, kiosk, or phone ticketing service.
- 5. The e-Gift Voucher is not applicable to K11 Art House Black Box/House 11, Festival Suite of Festival Grand Cinema, two-seaters of MCL Cyberport Cinema, film festivals, alternative programs, live broadcast programs, venue rental or group bookings and films with special arrangement with film distributors.
- 6. Supplementary charges will be levied for each ticket claimed using the e-Gift voucher if the movie version/house is: (i) 3D; (ii) MX4D; (iii) RealD Cinema (3D); (iv) Onyx Cinema LED; (v) K11 Art House IMAX/House 12; (vi) long duration or (vii) under any other special cases. Please enquire with our cinema staff for details.
- 7. The e-Gift Voucher can only be used for shows on or before the expiry date.
- 8. No refund will be provided regardless of the ticket value of the ticket claimed.
- 9. The e-Gift Voucher cannot be used in conjunction with any other promotional offers and cannot be exchanged for cash or other forms of value.
- 10. The e-Gift Voucher can be used once only and any copy is invalid. A maximum of 4 e-Gift Vouchers can be used to claim tickets of the same show.
- 11. The e-Gift Voucher will expire automatically after it is redeemed for movie tickets. The expired e-Gift Voucher cannot be reused or reissued. Any attempted fraud will result in criminal prosecution and civil claims.
- 12. If there is ambiguity about the validity period of the e-Gift Voucher, the version under MCL Cinemas ticketing system shall prevail.
- 13. The e-Gift Voucher is not for resale.
- 14. In case any cinema is closed temporarily due to construction, any special incidents or force majeure events or under expiry of tenancy, the e-Gift Voucher is still applicable to other cinema locations.
- 15. In case any cinema is closed temporarily due to construction, any special incidents or force majeure events or under expiry of tenancy, the validity of the e-Gift Voucher will not be extended.
- 16. MCL Cinemas reserves all rights to amend the terms and conditions and discontinue or terminate the use of the e-Gift Voucher without prior notice. If a new version of the Terms and Conditions is issued, this version will be replaced and the new version shall prevail.
- 17. MCL Cinemas reserves the right of final decision in case of any dispute.
- 18. If there are discrepancies between the English and Chinese versions of the terms and conditions, the Chinese version shall prevail.
