

**reward-U x HK Express Up to 15% off Fares Terms and Conditions:**

1. The reward-U x HK Express Up to 15% off Fares (the "Offer") is only applicable to holders of a designated BEA Credit Card ("Cardholders").
2. Offer is applicable to designated BEA Credit Cards including: BEA i-Titanium Card, Lingnan University MasterCard, EdUHK Visa Card, PolyU Visa Card, HKU Credit Card, and VTC Visa Card.
3. Cardholders who book tickets through HK Express' official website at <http://www.hkexpress.com> for travel between 12<sup>th</sup> June, 2017 and 24<sup>th</sup> March, 2018 (both dates inclusive), must input the specific promotional code **"RUBEAUN"** ("Promo Code") from the period between 12<sup>th</sup> June and 31<sup>st</sup> December, 2017 (both dates inclusive) ("Promotional Period") and settle payment in full with a designated BEA Credit Card shall be entitled to the following offers:
