

Bonus Points Rewards Terms and Conditions

1. The Bonus Points Rewards is only applicable to the cardholders of BEA SupremeGold World Mastercard or BEA World Mastercard (the "Cardholders").
2. Each principal card account and related supplementary card account(s) will be treated as one eligible account when calculating transactions and Bonus Points.
3. Transactions made by different card accounts held by the same Cardholder cannot be transferred or combined.
4. The monthly extra Bonus Points will be credited to the principal card account of the Cardholder between the 8th and the 15th of the next month and will appear on the related statement.
5. A computer system will be used to calculate transactions/Bonus Points. The records of The Bank of East Asia, Limited ("BEA") shall be final and conclusive.
6. The Cardholder's eligible account must be valid during the promotional period and at the time the Bonus Points are given. The Bonus Points earned are not transferrable.
7. Un-posted/cancelled/refunded transactions and transactions that are found fraudulent or eventually cancelled/refunded will be considered as ineligible transactions.
8. If a transaction proves to be ineligible, BEA shall be entitled to debit an amount equal to the value of the relevant Bonus Points from the Cardholder's account. The conversion rate for charging back Bonus Points is HK\$1 for every 200 Bonus Points (rounded up to the nearest Hong Kong dollar).
9. No person other than the cardholder or BEA will have any right under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong) to enforce or enjoy the benefit of any of the provisions of these Terms and Conditions.
10. BEA reserves the sole right to vary or cancel the promotion and/or amend or alter these Terms and Conditions at any time with appropriate notice. In the event of any dispute, the decision of BEA shall be final and conclusive.

(i) BEA Mileage Reward

1. BEA Mileage Reward is only applicable to the Cardholders who have registered for the BEA Mileage Reward.
2. In the event that the Cardholder does not register for the BEA Mileage Reward, the Cardholder will be enrolled for the BEA Bonus Point Reward automatically without prior notice. Each request to enrol for the BEA Mileage Reward thereafter will incur a handling charge of HK\$1,800 per principal card.
3. The 1.6X Bonus Points include the basic Bonus Points.

(ii) BEA Bonus Point Reward

1. BEA Bonus Point Reward is not applicable to the Cardholders who have registered for the BEA Mileage Reward.
2. The 2.4% rebate include the basic Bonus Points.
