

Terms and Conditions:

- 1. The offer is valid from 29th June to 12th July, 2020, both dates inclusive ("Promotional Period").
- 2. The offer applies to cardholders who use the designated price and Bonus Points to purchase one or more Cartier watches (the "watch") with a valid BEA Credit Card.
- 3. To enjoy the offer, the cardholder is required to call 3608 6628 to place the order during the Promotional Period. While placing the order, the cardholder should provide a valid BEA Credit Card number, cardholder name, the watch model, and the number of items desired.

The cardholder should ensure they have a sufficient credit limit with their card at the time the amount is charged, otherwise the order will be cancelled or an over credit limit fee will be charged without prior notice. The cardholder's account must be valid during the Collection Period and at the time the Bonus Points are deducted, otherwise the redemption will be cancelled automatically.

5. The redemption letter will be sent to the cardholder's mailing address (according to the record of The Bank of East Asia, Limited ("BEA")) on or before 31st July, 2020. All redemption letters which have been sent out or are already used are not returnable. The principal cardholder is required to bring along the original of redemption letter and principal credit card to collect the watch in person at the designated venue below on or before 31st August, 2020 ("Collection Period").
