

## Terms and Conditions:

1. "Special Reward of up to HK\$17,500 in Coupons & Gift Cards at Harbour City" (the "Rewards") applies to cardholders who settle any relevant payments to the participating merchants at Harbour City in full with a valid BEA credit card ("Cardholders"). The types of BEA credit card accepted may vary among the participating merchants. Please contact the relevant participating merchant for details.
2. The promotional period is from 1<sup>st</sup> February to 11<sup>th</sup> April, 2021 (the "Promotional Period").
3. By spending a designated amount during the Promotional Period, Cardholders can:
