

Terms and Conditions for BEA i-Titanium Card Exclusive Online Application Reward – Deliveroo (the “Exclusive Online Application Reward”)

- 1) New BEA i-Titanium Card cardholders who have fulfilled all the conditions below are eligible to receive the Exclusive Online Application Reward (the “Eligible Customers”):
 - a) Applied for a BEA i-Titanium Card basic card (the “Eligible Basic Card”) through the designated online channels between 21st January and 2nd March, 2020, both dates inclusive (the “Promotional Period”);
 - b) Had their Eligible Basic Card successfully approved and activated through the BEA App on or before 31st March, 2020 and made at least 1 retail purchase and/or cash advance with an aggregate eligible spending amount of HK\$100 or above (the “Spending Requirement”) with the new Basic Card on or before 30th April, 2020 (the “Spending Period”). The Spending Requirement excludes cash advance handling and administration fees and interest, Octopus Automatic Add Value Service, purchase and/or recharge of prepaid cards or digital wallets, casino transactions, fund transfers, foreign currency exchange, finance charges, cancelled transactions, late charges, credit card annual fees, online/Automatic Teller Machine (“ATM”) bill payments, tax payments, and any other transactions as determined by BEA from time to time. The Cardholder’s entitlement to the Exclusive Online Application Reward will be forfeited if his/her Eligible Basic Card does not fulfil the Spending Requirement within the Spending Period.
 - c) Have not held any principal BEA Credit Card (excluding the BEA Corporate Card and all co-branded/affinity cards and supplementary cards) within 6 months prior to applying for the BEA i-Titanium Card basic card.
- 2) BEA will deliver a promo code by SMS message to Eligible Customers* mobile number registered with BEA within 2 months after the end of the Spending Period.
- 3) The promo code can only be used for orders placed through Deliveroo in Hong Kong and paid for using the new BEA i-Titanium Card.
- 4) The promo code is valid for redemption until 11:59 p.m. on 31st March, 2021 and for 30 days once the promo code is redeemed. Each promo code can be used once only for a single transaction.
- 5) The promo code cannot be redeemed for cash or exchanged for other rewards, products or discount, and no change will be given. It cannot be used in conjunction with other promotional offers of Deliveroo and is non-refundable.
- 6) Terms and conditions of Deliveroo apply to use of the promo code. The bank will bear no liability relating to any aspect on the relevant product and services.
