

Cash Rebate Offer Terms and Conditions:

- 1. Offer applies to the principal cardholders of a BEA Visa Card or Mastercard (the "Eligible Cardholder"). The BEA i-Titanium Card, BEA Corporate Card, and supplementary cards are excluded.
- Eligible Cardholders must enter the designated coupon codes on the checkout page to enjoy the offer. <u>If a hotel</u> <u>booking transaction is cancelled or the entire amount is refunded, the relevant cash rebate conversion request will be</u> <u>automatically cancelled without prior notice.</u> Otherwise, the relevant cash rebate conversion cannot be amended or <u>reversed.</u>
- 3. If a non-eligible cardholder enters the coupon codes for cash rebate conversion on the checkout page, cardholder can enjoy the hotel discount offer only and the relevant cash rebate conversion request will be automatically cancelled without prior notice.
- 4. A computer system will be used to calculate transactions and rebate. The records of The Bank of East Asia, Limited ("BEA") shall be final and conclusive. Cash rebate will be credited to the relevant principal card account during the periods below, and will appear on the relevant statement:

- 5. BEA's acceptance of a cash rebate conversion request is subject to the accumulation of sufficient Bonus Points by the Eligible Cardholder at the time the rebate is given. The required Bonus Points will be deducted from the card account with which the Eligible Cardholder has made the relevant transaction. If the Eligible Cardholder's card account does not have sufficient Bonus Points, the cash rebate conversion request will be automatically cancelled without prior notice.
- 6. Un-posted/cancelled/refunded (the entire amount) transactions and transactions that are found fraudulent or eventually cancelled/ refunded will be considered ineligible.
- 7. If a transaction proves to be ineligible, BEA shall be entitled to debit an amount equal to the value of the relevant Bonus Points/rebate from the card account of Eligible Cardholder.
- 8. The card account of Eligible Cardholder must be valid during the promotional period and at the time the rebate is given. The rebate cannot be converted into cash and is not transferrable either to third parties or any other accounts held by the Eligible Cardholder.
