#### Terms and Conditions for BEA Mastercard Debit Card Welcome Offer

#### **Promotion Period**

 The promotion period of the "BEA Mastercard Debit Card Welcome offer" (the "Promotion") held by The Bank of East Asia, Limited ("BEA" / the "Bank") runs from 30 October 2025 to 31 January 2026, both dates inclusive (the "Promotion Period"), unless otherwise specified.

#### **Eligible Customers**

- 2. The Promotion is only applicable to any principal cardholder (the "Eligible Customer" ) of the BEA Mastercard Debit Card (the "Eligible Debit Card" ) issued by the Bank who meets the following conditions:

# **Spending Rewards Setting**

3. Upon successful application and activation of the Eligible Debit Card, the default spending rewards will be set to "Cash Rebates". Customers may switch to "Bonus Points" via BEA Mobile. The new setting will be effective on the 1<sup>st</sup> day of the following month. #### Welcome Offer

## c. Foreign Currency Transaction Reward
