

# A. General Terms and Conditions

## **B.** Account Opening Reward

- 1. Reward applies to customers who open a new i-Account through designated BEA branches or the BEA Flash mobile app successfully during the Promotional Period (the "Eligible Customer").
- 2. <u>Account application through designated BEA branch</u>: The customer must bring (i) a valid student identity card, (ii) proof of identity, e.g. HKID card or passport, and (iii) proof of residential address in English, bearing their name and issued within the past 3 months to any of our designated BEA branches to open an i-Account during the Promotional Period.

Designated BEA branches include Hong Kong Baptist University i-Financial Centre, North Point Branch, Lingnan University i-Financial Centre, the Chinese University of Hong Kong Branch, the Education University of Hong Kong Branch, the Hong Kong Polytechnic University Branch, the Hong Kong University of Science and Technology Branch, Mongkok Branch, and the University of Hong Kong Branch.

- 3. <u>Account application through BEA Flash</u>: The customer must enter "UNI" followed by their year of graduation into the "Promotion code" field during the BEA Flash account opening process, to open an i-Account during the Promotional Period.( E.g. If the customer graduates in 2024, they should enter "UNI2024").
- 4. To be eligible for Foldable Bluetooth Keyboard (standard retail price: HK\$260) (the "Welcome Gift"), the Eligible Customer must deposit initial funds of HK\$5,000 within 1 month from the date the i-Account is opened and keep it there until designated date as set out in Table 1.

- 6. A customer who has held an all-in-one Account with BEA either individually or jointly in the 12 months prior to the date their i-Account is opened will be ineligible to receive the Welcome Gift.

- 8. The Welcome Gift will be available on a first-come, first-served basis while stock lasts. If the Welcome Gift is out of stock, BEA reserves the right to offer other vouchers /gifts instead of the Welcome Gift at its sole discretion.

# C. Digital Banking Reward

### i. Reward for logging in to the BEA App

- 1. Each Eligible Customer who have logged in to the BEA App for the first time will be entitled to HK\$50 cash reward (apply to i-Account customers) /spending credit (apply to credit card customers). If customer is a i-Account and credit card holder, the Bank will deposit the cash reward into the i-Account.
- 2. The reward will be credited (without prior notification) to Eligible Customer's new i-Account opened through BEA Flash /BEA branch or principal card account within 90 working days of the end of the Promotional Period.

#### ii. Reward for completing designated e-transactions (Only applicable to customers who opened account at BEA branch)
