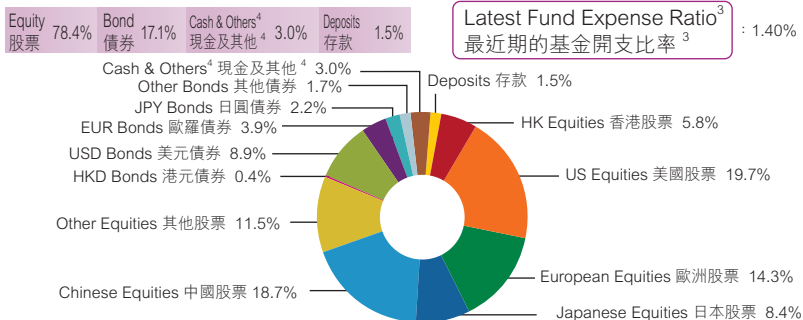

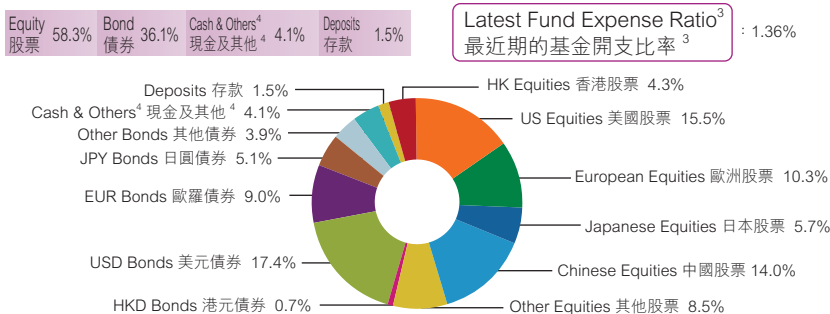

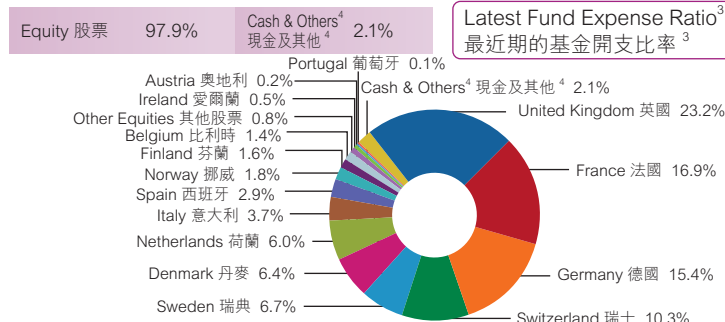

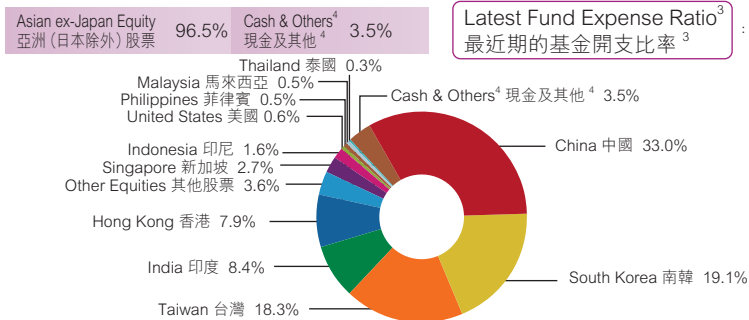

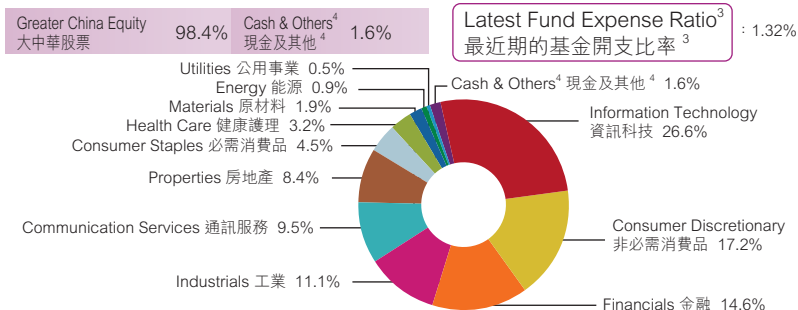

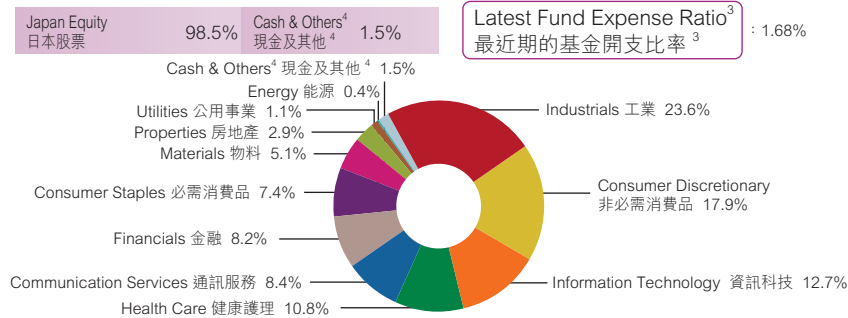

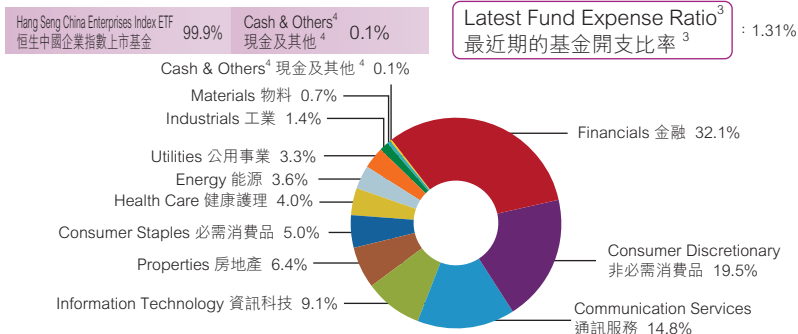

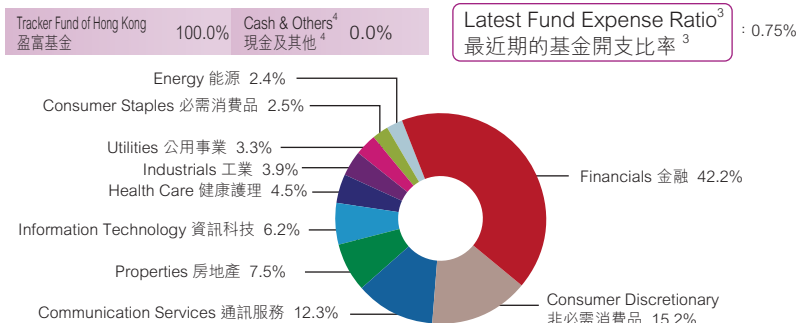

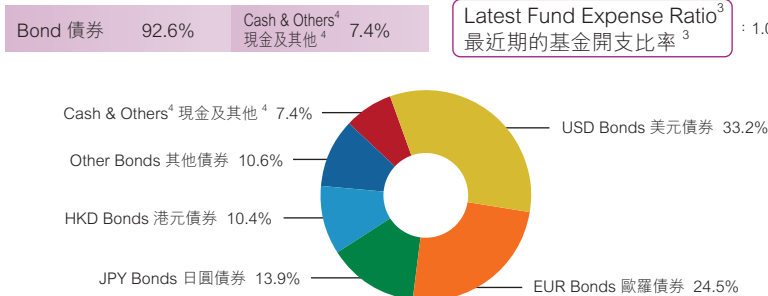

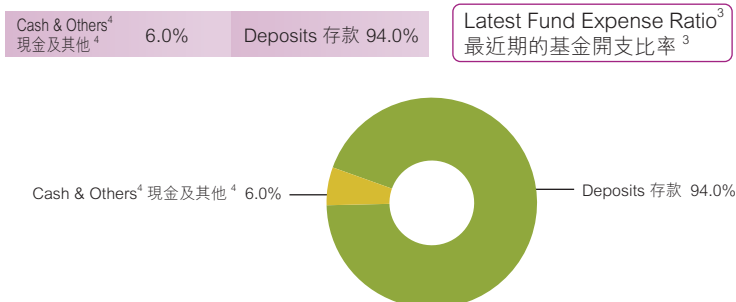

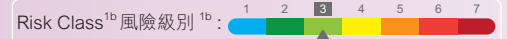
Commentary 評論

- New COVID-19 cases continued to rise, forcing governments to reimpose localised lockdowns, particularly in Europe and parts of U.S. Vaccine news, however, was extremely positive. Fatality rates were stable. Economic recovery stayed on track. Global manufacturing outlook remained robust as our global PMI rose to a 34-month high, global industrial output growth turned positive for the first time this year, financial conditions eased even more, and economic surprises were positive for an eighth successive month. Earnings estimates ticked up further. Rising lockdowns, however, will impact GDP adversely in the first quarter of 2021, though the front-loaded \$900bn U.S. fiscal package will help. Global inflation eased to 1.3% from 1.4%. China's CPI contract -0.5% yoy on base effects. However, both market-traded inflation swaps and our leading indicator predict inflation rising towards 2% in 2021. Implied volatilities remained below their long-term average on positive risk orientation.
- Equities had another strong month with global market cap zooming past \$100 trillion. 37/40 markets we tracked ended in the green. The median local currency return was 3.8%! Small Caps, EMs and Technology outperformed. Median 2020 return went into positive territory at 1.8%, with 23/40 markets in the green.
- With regards to fixed income, policy rates remained abysmally low (our Global policy rate indicator was at 1.04%, with developed markets at 0.01% and emerging markets at 2.74%). Our Global Sovereign 10-yr yield indicator finished -3bps at 1.94% as risk-premiums in global sovereign bonds declined. Credit spreads narrowed further.

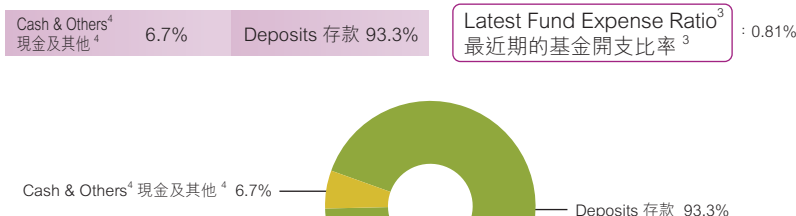

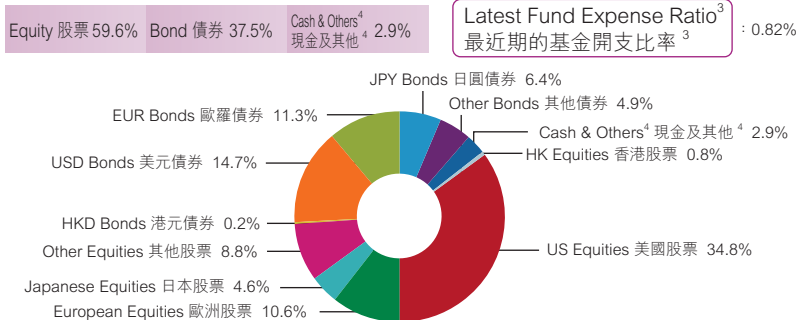

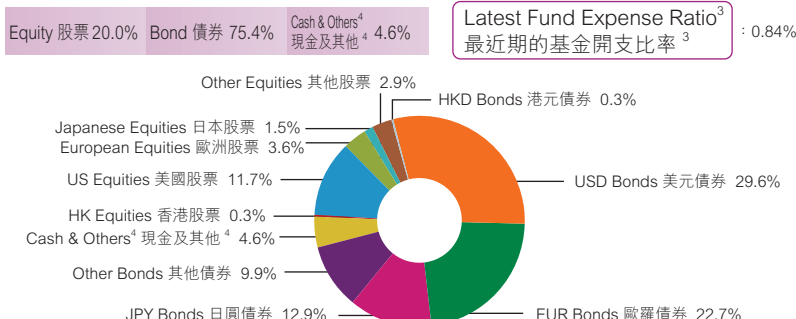

(This only applies if the member is employed in a company participating in the Master Trust). Such qualifying period is determined at the scheme account level. The qualifying period may also be reset to zero if the member (or his personal representative) effects a redemption, switching out or withdrawal of investments from the BEA (MPF) Long Term Guaranteed Fund other than upon the occurrence of a qualifying event. For the avoidance of doubt, condition (f) does not apply to self-employed persons, personal account holders, Special Voluntary Contribution Account Members or Tax Deductible Voluntary Contribution Account holders; (g) Terminal illness. The conditions (a) to (e), and (g) apply to employee members, self-employed persons, personal account holders, Special Voluntary Contribution Account Members and Tax Deductible Voluntary Contribution Account holders. If a redemption, switching out or withdrawal of the units of the fund is effected other than the occurrence of a qualifying event as stated above, the guarantee will be affected. Special terms and conditions apply regarding how the guarantee operates. Please refer to the Appendix 1 of the MPF Scheme Brochure for details of the credit risk, guarantee features and guarantee conditions of this constituent fund.

To invest in DIS, member's instruction must be an instruction to invest 100% of: (A) existing accrued benefits and/or (B) future contributions and accrued benefits transferred from another scheme in the DIS.
De-risking mechanism will not apply where the member chooses these constituent funds as standalone investments (rather than as part of the DIS). However, the funds with same name under DIS and non-DIS have the same unit prices.

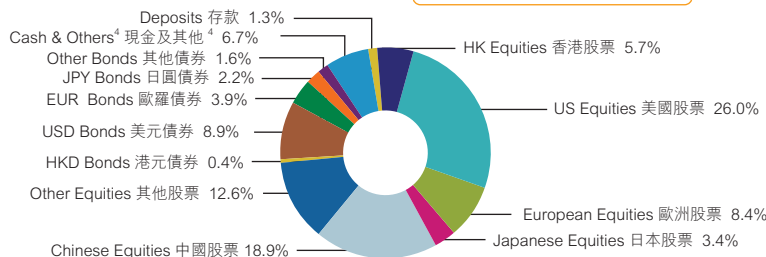

Commentary 評論

- The U.S. equities rose to record high on the last trading day of 2020. The power transition in the U.S. is smooth, and the Democrats won the control of the Senate and the House of Representative. Historically, "blue wave" spur stock rally.
- On the back of synchronized global central banks' liquidity injection as well as worldwide governments' fiscal stimulus support, macroeconomic data and market sentiment sharply improved since the middle of 2020.
- European stocks surged in last December. Although the region still hit by COVID-19, European Central Banks maintained interest rate extremely low and launched additional asset purchase program to support the market.
- In China, based on strong domestic demand and expectations for COVID vaccine deployment, the economics shows a rapid recovery. The growth of some sectors has reached the pre-COVID levels.

- 美股在2020年最後一個交易日創下歷史新高。美國總統換屆權力交接順利，加上民主黨同時取得參眾兩院控制權。歷史上，每當「藍色浪潮」出現，均能刺激美股上升。
- 再者，環球央行不約而同維持寬鬆貨幣政策，為市場注入資金；加上各國政府的財政刺激政策支持，令去年中以來，宏觀經濟數據及市場氣氛均呈現顯著改善。
- 歐洲股市於12月錄得升幅，儘管歐洲各地仍受新冠肺炎肆虐，惟歐洲央行維持超低息水平以及加碼購債計劃規模，為市場帶來支持。

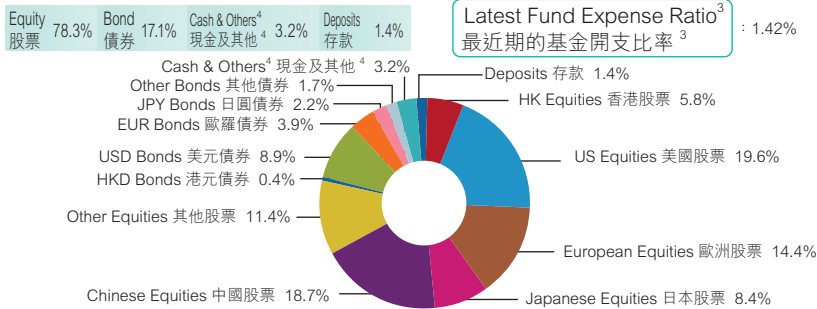

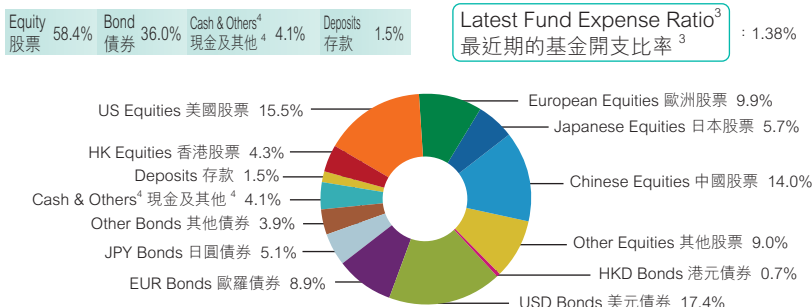

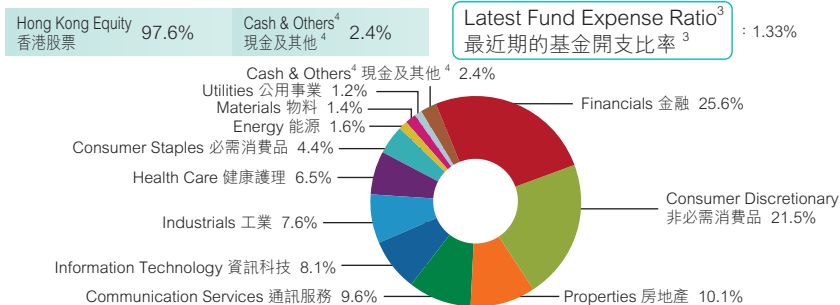

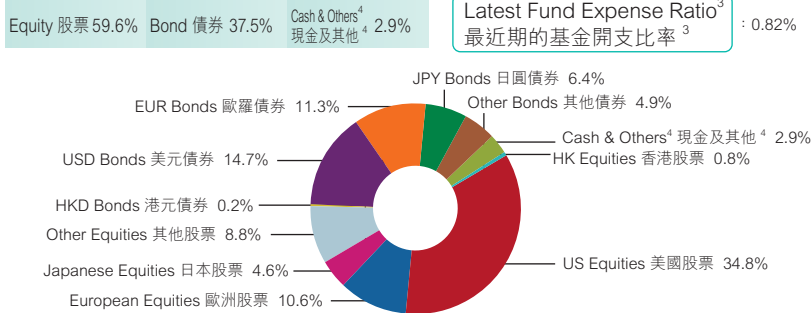

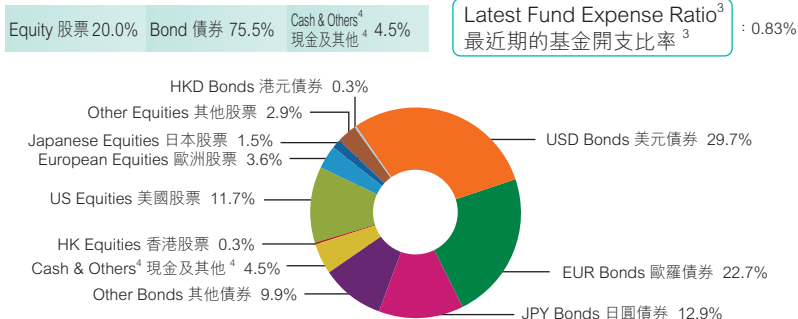

For those members who do not make an investment choice, their future contributions and accrued benefits transferred from another MPF scheme will be invested in accordance with the DIS.

DIS is not a fund - it is a strategy that uses two constituent funds, i.e. the BEA (Industry Scheme) Core Accumulation Fund (the "Core Accumulation Fund") and BEA (Industry Scheme) Age 65 Plus Fund (the "Age 65 Plus Fund") to automatically reduce the risk exposure as the member approaches retirement age. Core Accumulation Fund will invest around 60% in higher risk assets (higher risk assets generally means equities or similar investments) whereas the Age 65 Plus Fund will invest around 20% in higher risk assets. Switching of the existing accrued benefits among Core Accumulation Fund and Age 65 Plus Fund will be automatically carried out each year on a member's birthday from the age of 50 to 64 and according to the allocation percentages as shown in the DIS de-risking table.

To invest in DIS, member's instruction must be an instruction to invest 100% of: (A) existing accrued benefits and/or (B) future contributions and accrued benefits transferred from another scheme in the DIS.

De-risking mechanism will not apply where the member chooses these constituent funds as standalone investments (rather than as part of the DIS). However, the funds with same name under DIS and non-DIS have the same unit prices.
