

Terms and Conditions of the Campaign

1. The “PAY & TRANSFER LUCKY DRAW” (the “Campaign”) is organised by The Bank of East Asia, Limited (“BEA”).
2. The Campaign only applies to customers who meet the following requirements (“Eligible Participants”):
 - are aged 18 or above;
 - hold a valid Hong Kong Identity Card; and
 - have a valid email address registered in the Bank’s records.
 Any person who does not fulfil the above qualifications will not be eligible to participate in the Campaign.
3. The Campaign runs from 4th May to 31st July, 2022 (both dates inclusive) (the “Promotional Period”). The Campaign will be held in 3 stages within the Promotional Period as listed below:

Stage 1	4 th – 31 st May, 2022
Stage 2	1 st – 30 th June, 2022
Stage 3	1 st – 31 st July, 2022

4. Each Eligible Participant who completes the following designated action through the BEA App or Cyberbanking and fulfils the detailed requirements for each action within the Promotional Period will be automatically entitled to a designated number of Lucky Draw entries.

Complete a transaction through Pay! (FPS)	Each transaction must be at least HK\$50 or equivalent, with the transaction amount being posted in the account.	1 chance	20 chances
Complete a transaction through “Transfers”	Each transaction must be at least HK\$50 or equivalent, with the transaction amount being posted in the account.	1 chance	
Make a bill payment	Each transaction must be at least HK\$100 or equivalent, with the transaction amount being posted in the account.	1 chance	
Complete an outward remittance	Each transaction must be at least HK\$50 or equivalent, with the transaction amount being posted in the account.	3 chances	

5. Mechanism and prize:
 - Mechanism: Lucky draw will be held once in each stage, and winners will be drawn randomly by the computer system.

- Prize: 1 latest model of 2-in-1 laptop (worth: HK\$12,988).

 8. Any transaction that is not conducted through the BEA App or Cyberbanking will not be counted as an eligible transaction.
 9. Prize collection:
 - Winners will be notified by email about the prize collection arrangement on or before 31st October, 2022. The notification email will be sent to each winner's email address as registered with BEA.
 - The prize will be forfeited if the winner has never registered an email address through a BEA branch or Cyberbanking either before or during the Promotional Period or if that email address is not valid at the time the prize is given.
 - The winners' BEA bank accounts, email address, and Cyberbanking accounts must be valid at the time the prize is given.
 - The prizes are non-transferable and cannot be exchanged or redeemed for cash or other products.
 - The prizes will only be awarded in Hong Kong.
 - The results, date, and time of the Campaign will be determined by the records in BEA's computer systems. BEA reserves the sole and absolute right to determine the participant's eligibility to receive the prize and make conclusive decisions.
 - After the prizes have been delivered, they cannot be changed, transferred, returned, or converted into cash, and will not be re-issued. The prizes shall only be used in accordance with the supplier's terms and conditions.

In case of any breach of these terms and conditions, or any dishonest conduct and/or acts of counterfeit, BEA reserves the sole right to immediately cancel the participant's entitlement to a prize without prior notice.
4. A computer system arranged by BEA will be used to calculate the transactions. BEA's records and the results of its calculations shall be final and conclusive.

BEA shall not be responsible for any matters arising from or in connection with the submission, delay, loss, or transmission error of any information of the participant due to technical problems, including but not limited to any computer or internet network problems. All relevant dates and times of the Campaign (including but not limited to the date and time of participation) will be based on the information as recorded in BEA's computer systems. BEA reserves the sole and absolute right to make final and conclusive decisions.
6. BEA reserves the sole right to vary or cancel the Campaign and/or amend or alter these Terms and Conditions at any time without prior notice. In the event of any dispute, the decision of BEA shall be final and conclusive.
7. If a participant is found to have adopted any way to invade and/or modify the computer program to participate in this campaign, BEA reserves the sole right to cancel the participant's entitlement to any prizes. The participant will bear all related responsibilities, liabilities, and consequences.
8. No person other than the Eligible Participant or BEA will have any right under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong) to enforce or enjoy the benefit of any of the provisions of these Terms and Conditions.
9. Employees of The Bank of East Asia related to the promotion and their relatives are ineligible to participate in the Campaign. BEA reserves the sole and absolute right to interpret and determine the definition of "The Bank of East Asia", "related to the promotion", and "relatives".
