

## “Mobile Wallet Binding Welcome Reward (Wave 2)” Terms and Conditions

1. The Promotion of “Mobile Wallet Binding Welcome Reward (Wave 2)” (the “**Promotion**”) is only applicable to the primary account holders of Applicable Bank Accounts (as defined in Clause 2 below) of The Bank of East Asia, Limited (the “**Bank**” or “**BEA**”) who has never linked their Applicable Bank Accounts to any of the mobile wallets (as defined in Clause 5 below) (“**Eligible Customer**”).
2. “**Applicable Bank Accounts**” refer to a customer who is an existing deposit account holder of BEA (including an existing deposit account / i-Account / BEA GOAL / Supreme Account / SupremeGold Account / SupremeGold Private Account / Private Banking).
3. The Promotion is not applicable to Cross-Boundary Wealth Management Connect customers.
4. The promotion period is from August 26, 2022 to November 30, 2022 (both dates inclusive) (the “**Promotion Period**”).
5. Eligible Customer has to complete the designated actions in the following table within the Promotion Period in order to receive the reward.

6. Each Eligible Customer is only entitled for the First-time Linkage Reward once and/or the Transaction Reward up to HK\$50 during the Promotion Period.
7. The cash reward will be credited to Eligible Customer’s Successfully Linked Account by February 28, 2023.
8. The cash reward is available on a first-come, first-served basis.
9. The winner’s Successfully Linked Account, mobile wallet and Cyberbanking account

must be valid at the time the reward is credited.

10. The results, date, and time of the Promotion will be determined by the records in BEA's computer systems. BEA reserves the sole and absolute right to determine the Eligible Customer's eligibility to receive the reward and make conclusive decisions.
11. BEA reserves the sole right to recover the reward from any reward winner or the equivalent value of the reward awarded to him/her if BEA discovers that he/she does not fulfil the requirements to obtain the reward or has violated any of these Terms and Conditions.
12. The rewards of the Promotion, number of winners, and entitlement to the rewards will be announced by BEA. BEA reserves the sole and absolute right to make final and conclusive decisions.
13. Participation in the Promotion is voluntary, and BEA shall not be responsible for any disputes or liabilities arising from or caused by the Promotion or the rewards. BEA shall not be responsible for any related obligations or costs incurred by participating in the Promotion.
14. Participation in the Promotion represents the Eligible Customer's understanding of, acceptance, and willingness to comply with the terms and conditions for the Promotion and rewards. In case of any breach of these terms and conditions, or any dishonest conduct and/or acts of counterfeit, BEA reserves the sole right to immediately cancel the Eligible Customer's entitlement to a reward without prior notice.
15. A computer system arranged by BEA will be used to calculate the transactions. BEA's records and the results of its calculations shall be final and conclusive.
16. BEA shall not be responsible for any matters arising from or in connection with the submission, delay, loss, or transmission error of any information of the Eligible Customer due to technical problems, including but not limited to any computer or internet network problems. All relevant dates and times of the Promotion (including but not limited to the date and time of participation) will be based on the information as recorded in BEA's computer systems. BEA reserves the sole and absolute right to make final and conclusive decisions.
17. BEA reserves the sole right to vary or cancel the Promotion and/or amend or alter these Terms and Conditions at any time without prior notice. In the event of any dispute, the decision of BEA shall be final and conclusive.
18. If the Eligible Customer is found to have adopted any way to invade and/or modify the computer program to participate in this Promotion, BEA reserves the sole right to cancel the Eligible Customer's entitlement to any rewards. The Eligible Customer will bear all related responsibilities, liabilities, and consequences.
19. Eligible Customers are responsible for the relevant data charges incurred by downloading and/or using the BEA app and/or BEA Cyberbanking and/or any of the mobile wallets.

20. BEA is not the supplier of any of the mobile wallets mentioned in Clause 5 above. Use of the mobile wallet(s) is subject to the terms and conditions stipulated by the supplier. BEA assumes no liability or responsibilities for the terms and conditions and any other matters relating to the mobile wallet(s). Should there be any dispute or complaint or claim (if any) with regard to the mobile wallet(s), Eligible Customer should make such demand or claim directly with the supplier.
21. No person other than the Eligible Customers or BEA will have any right under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong) to enforce or enjoy the benefit of any of the provisions of these terms and conditions.
22. These terms and conditions shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region.
23. Should there be any discrepancy or inconsistency between the English and the Chinese versions of these terms and conditions, the English version shall prevail.
