Terms and Conditions for "New BEA Credit Card Cardholders First Time Login BEA Mobile"

- 1. The "New BEA Credit Card Cardholders First Time Login BEA Mobile" (the "Promotion") is organised by The Bank of East Asia, Limited ("BEA").
- 2. The Promotion runs from 1st July 2023 to 31st March 2024 (both dates inclusive) (the "Promotional Period").
- 3. Participants ("Eligible Participants") of the Promotion must:
 - be aged 18 or above;
 - hold a valid Hong Kong Identity Card;
 - have not logged into the BEA Mobile;
 - have not maintained any deposit accounts with BEA;
 - apply for the Designated BEA principal card successfully (as defined in Clause 4) during the Promotional Period; and
 - have any of their newly applied Designated BEA cards approved on or before the specified date below:

Any person who does not fulfil any of the above qualifications will not be eligible to participate in the Promotion.

- 4. Designated BEA cards include:
 - BEA World Mastercard
 - BEA i-Titanium Card
 - BEA UnionPay Dual Currency DIAMOND Credit Card
- 5. The Eligible Participant must successfully log in to the BEA Mobile for the first time within 2 months of the card's issue date to receive a HK\$50 rebate (the "Reward").
- 6. Each Eligible Participant can be rewarded at most once (i.e. HK\$50 rebate) during the Promotional Period.
- 7. The Eligible Participant's BEA Online account must remain valid at the time the Reward is credited.
- 8. Reward Arrangements
 - The Reward will be credited to the principal BEA credit card account according to schedule below, and will appear on the related statement without prior notice.

For example: if the reward recipient successfully applies a BEA World Mastercard and a BEA i-Titanium card, the reward will be credited to the BEA World Mastercard account.

- The Reward cannot be redeemed for cash and is non-transferrable. The Reward can be used to offset the balance of the relevant credit card account.

The participant will bear all related responsibilities, liabilities, and consequences.
- 8. Participants are responsible for the relevant data charges incurred by downloading and/or using the BEA Mobile and/or BEA Online.



- 9. Participants should download the BEA Mobile from official application stores or BEA website, and ensure the search wording is correct.
- 10. By using the BEA Mobile and/or BEA Online, the Participant agrees to be bound by the content of the disclaimer and policy as it may be amended by BEA from time to time and posted on the BEA Mobile and/or BEA Online.
- 11. No person other than the Eligible Participant or BEA will have any right under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong) to enforce or enjoy the benefit of any of the provisions of these Terms and Conditions.
- 12. This Promotion does not apply to Cross-boundary Wealth Management Connect customers.
- 13. These Terms and Conditions are governed by and will be construed in accordance with the laws of the Hong Kong Special Administrative Region.
