- 3. The cash rebate can only be credited to the relevant eligible principal card account. All cash rebates are non-transferable.

- **5.** A computer system will be used to calculate transactions/cash rebates. The records of The Bank of East Asia, Limited ("BEA") shall be final and conclusive.
